RESOLVED that Proposed Local Law 3-2010 be and is hereby adopted and shall read as follows:

LOCAL LAW NO. 4-2010

A local law amending Chapter 326 (Vehicles and Traffic) Article V (Metered Parking Zones) Section 54 (Fees) Zones 10(a), 10(d) and 10(e) of the Code of the Village of Mamaroneck.

Be it enacted by the Board of Trustees of the Village of Mamaroneck as follows:

SECTION 1.

That Village Code Chapter 326-54 parts K., N. and P. of the Village of Mamaroneck Vehicle and Traffic Law are deleted in their entirety.

SECTION 2.

That new language for Village Code Chapter 326-54 parts K., N. and P. of the Village of Mamaroneck Vehicle and Traffic Law is hereby enacted, as follows:

K. A fee of \$0.25 for 30 minutes, or any fraction thereof, for a maximum of two hours, is hereby established for parking in the first through sixth spaces commencing from Sheldrake Place in Metered Parking Zone 2(b), and for the metered spaces in Parking Zone 10(d).

N. A fee of \$0.25 for 20 minutes, or any fraction thereof, for a maximum of two hours, is hereby established for parking in Metered Parking Zones 9, 12, 13, 14, 15, 16(a), (16)b and 17.

P. A fee of \$0.25 for 30 minutes or any fraction thereof, for a maximum of eight hours, is hereby established for parking in Metered Parking Zones 10(a) and 10(e), with no minimum.

SECTION 3. Effective Date

This Local Law shall take effect immediately upon adoption and filing in the office of the Secretary of State in accordance with the Municipal Home Rule Law.
