Meeting called to order at 6:35 pm.

Approval of May 4, 2008 Recreation and Parks Commission minutes. Commissioner Maryanne Genovese made a motion. Commissioner Pat Radogna seconded.

Denise Gilman, from Westchester CAP Center in Mamaroneck asked permission to bring 18 children and 3 adults to the beach during the summer between June 30th and August 30th. They ask every year for this permit and only bring the kids down on very hot days. Commissioner Steve Scarangella made a motion to approve and Commissioner Manny Enes seconded.

Supt. Rosanne Saracino gave a Day Camp Update on enrollment. There are 106 children enrolled as of today. Our camp is also open to non-residents and 9th graders.

Sailing Update – No word from Village Manager, Lenny Verrastro from Joe McGuinness.

Life of God Ministry's permit was brought up and Superintendent Rosanne Saracino checked with Village Attorney, Janet Insardi and there are no restrictions on this permit.

Commissioner Manny Enes made a motion that all the Recreation & Parks Commission Minutes are distributed to the Village Board of Trustees as to keep them informed of what our needs are. Commissioner Steve Scarangella seconded it.

Sport Time update. Village Manager, Leonard Verrastro told Supt. Rosanne Saracino that our camp would not fit at SporTime.

Commissioner Maryanne Genovese made a formal request to Trustee Liaison, Randi Robinowitz to find out a decision about the showers in the bathrooms.

The Commission discussed a prorated three and four week camp fee. It was unanimously agreed not to approve this. Commissioner Steve Scarangella made a motion, Commissioner Maryanne Genovese seconded.

Supt. Rosanne Saracino brought up the Street Fair/Beach Issue. Originally, we were going to keep the Sprayground open and the Beach closed. The Commission unanimously agreed to keep the beach closed but staff the Beach Manager on duty. The Beach will be closed that day, June 22nd. Commissioner Manny Enes made a motion to keep the beach closed. Commissioner Steve Scarangella seconded.

Supt. Rosanne Saracino made a suggestion to raise the fees for dance classes in the fall which would make it \$15.00 more a session which would increase it \$1 more a class. The Committee agreed that Supt. Saracino could raise the fees as she sees fit.

Commissioner Manny Enes suggested that the Board of Trustees and the Village Manager be invited to our next Parks & Rec. Commission in July.

Commissioner Craig Casterella made a motion to adjourn the meeting. Commissioner Pat Radogna seconded.

Meeting adjourned at 7:45 pm.
