## **Minutes Approved**

Village Manager, Richard Slingerland addressed the topic of shared summer camp services. The Village has endeavored over the past three years to combine/share summer camp programming and services with the Town of Mamaroneck. At this juncture there does not seem to be any real way to share camp services.

- Dates will be Thursday, July 1 through and including Friday, Aug 6

Therefore camp will be 6 weeks as it had been in the past.

Motion was made by M anny Enes to continue to pursue a permanent location for day camp; motion was seconded by Skip Pennucci.

Village Manager will re examine the ramp and trailer parking issues in Harbor Island Park as many boaters use HIP and do not pay to park or use the boat ramp as they arrive before and/or after the parking booth is staffed.

Field use surcharge was discussed with the Village Manager who will apprise the Board of Trustees of this surcharge. Recreation Commission reviewed the City of Rye Board resolution of 2003 for a field use surcharge.

The Recreation Commission is concerned about the fact that Little League may groom the Little League (Goetz) field in HIP and no other group is allowed to groom their respective fields. Village Manager, Rich Slingerland will check into the history of this practice with Little League.

Village Manager Slingerland believes that improvements should be made to Philips Park Road park area.

Commissioner Tom Cook made a motion to adjourn the meeting at 8:45 p.m. Motion was seconded by Commissioner Manny Enes.
