#### **Minutes Approved**

A motion was made by Commissioner Steve Scarangella and seconded by Commissioner Tom Cook to approve the Parks and Recreation Commission minutes for the meeting of August 3, 2009. Minutes were unanimously approved.

#### Superintendent's Update

Superintendent of Recreation, Rosanne Saracino reviewed her monthly update; provided time for questions and answers.

### **Old Business**

Recreation Commission wants to be relieved of the responsibility of approving field permits. The Commission wants to focus on other recreation issues and situations. Trustee Toni Ryan will speak with Village Manager Richard Slingerland regarding this consideration of the Recreation Commission.

#### **New Business**

Field Permits: (see attachments for actual permit requests and actions)

- 1. Westchester Women's Soccer-Meg Moriarty presented the request. If they meet the 80/20 rule the Commission would approve this request.
- 2. Mamaroneck Midget Football –Mike Mollin presented the request. Commission denied as if one team does this all teams will want to cook for their respective team.

### Village Manager Projects

The Commission would like to address the following with the Village Manager:

- 1. Larger spray ground or another spray ground
- 2. Florence Park and Warren Ave Park become active parks for soccer, T- ball, kickball, flag football BUT for the **youngest** groups only.

  Florence Park should become active for soccer, football, possibly softball for **older** groups.
  - The extra use of Florence and Warren will necessitate additional maintenance.
     Perhaps a work schedule for parks Dept for some staff to work Tuesday-Saturday or Wednesday Sunday in this fashion there would be weekend coverage for the parks.
  - There would be time restrictions and guidelines for games and practices in an
    effort to be good neighbors with the immediate neighbors and have parking for all.
    One game at a time would be played or practiced with a 15 minute delay before
    the next game or practice. This was implemented years ago and this practice
    worked very well.
- 3. Rent out Pavilion.
- 4. Larger concession for Harbor Island Park.
- 5. Taylor's Lane as a passive Park.
- 6. Fields use surcharge (separate account just for Recreation use) This was the subject of several Recreation Commission meetings a few years ago.

Recreation Commission packets will be emailed starting next month.

Commissioner Steve Scarangella made a motion to adjourn at 9:15 p.m. Motion was seconded by Commissioner Guy Pipolo.

Next meeting will be Wednesday, October 14, 7 p.m. in the Court Room.
