1. Turkey Trot is still being discussed by the Recreation Commission. Motion was made by Manny Enes to make the Turkey Trot a 5 K as opposed to a 5 mile race; seconded by Steve Scarangella; all in favor. Superintendent Saracino will check on adding some entertainment for the program by consulting with Westchester Road Runners as to what other road races offer.

2. Motion was made by Skip Pennucci that all recommendations from the Recreation Commission to the Board of Trustees be acknowledged by the next Recreation Commission meeting; seconded by Howard Jordan; all in favor.
