**CALL TO ORDER**

Dr. Tannenbaum called to order the Regular Meeting at 7:48 p.m.

**New Business**

**1. Liberty Enterprises – Request to bring offices (15 employees) to 109 Spencer Place – from Village Manager**

The Traffic Commission supports this move. They suggest, due to limited parking, that the employees take public transportation, or get Village parking permits. Dr. Tannenbaum noted that there is a metered parking lot across the street from this location.

**Old Business**

**1. Sarah Neuman – No parking on the north side of Palmer Avenue from driveway to rear of Sarah Neuman at 845 Palmer Avenue to a point 20’ east thereof.**

This request was made by the Fire Department as it is a tight, right turn to enter the driveway as cars park right up to the driveway.

**2. Dubois Avenue – Removal of three-hour parking sign**

### **3. Jensen Avenue – Request for sidewalk**

The Traffic Commission agrees with the request to add a sidewalk. This matter is being referred to the Building Department.

### **Other New Business.**

The Traffic Commission, under the guidance of Mr. Brendolan, will summarize parking in the Orienta area. A realistic formula will be used to determine no parking and parking zones that will be consistent throughout this area.

Dr. Tannenbaum revisited a resident's request to return one parking space on Sophia Street. A site visit took place. The Traffic Commission agreed to modify their recent decision. Two parking spaces were removed on Sophia Street recently. The Traffic Commission agreed to return one parking space.
