CALL TO ORDER

Mr. Mazzullo called to order the Regular Meeting at 7:37 p.m.

Old Business

1. 1015 Old Post Road – Additional Parking Requested. Discussed at November meeting.

Mr. Mazzullo adjourned this matter to the March 8, 2012 meeting.

New Business

Mr. Robert Sperber sent a letter to Mayor Rosenblum addressing the intersection at Boston Post Road and Mamaroneck Avenue. He stated that vehicles and trucks are parking and stopping in the No Parking zone. Mr. Sperber said that recently he had to come to a full stop as a truck was parked in the no parking zone and partially in the driving lane. He suggested that a stanchion be put up. Mr. Mazzullo said that this is not the ideal time of year to do this work due to snow plowing, and the pavement being too cold for the adhesive to adhere. The Board discussed options such as putting up a Tow Away Zone sign with a \$250. fine, removing the three parking spaces behind the no parking space, and putting up rubber bases with reflector poles.

Mr. Parisen joined the meeting at 7:55 p.m.

Mr. Mazzullo said that it is an enforcement issue. Officer Jaeger said he will relay this information to his office.

Mr. Mazzullo said that he will e-mail the Mayor about the options discussed.

Other

Mr. Parisen noted that the sign for volunteer personnel at Sheldrake Place has not been changed and should read: *Parking for Fire Officials Only*. He said that the replacement signage should be put up right away.

Mr. Parisen stated that a Trustee should attend the Traffic meetings. He said that a status on matters that were voted on, and also a time frame when work will be completed, is important to the Board. Mr. Porretto agreed and said that much time is expended discussing the agenda. Mr. Mazzullo said that he will send an e-mail to the Mayor on the aforementioned topics.

Mr. Porretto addressed the bus stop at 904 Mamaroneck Avenue that is next to the school. When the bus pulls up, ones' line of vision is compromised. He suggested that the County be contacted to move the stop. The Board discussed and noted that there are two other bus stops nearby, and the stop in question may not be necessary, or the stop can be moved back one block further away from the school. Mr. Mazzullo said he will look into this and report back.

Mr. Parisen addressed the Rye Neck Getty gas station at 1275 East Boston Post Road. He said that cars from the gas station are moved to the road after being repaired, and in some instances are in the road all day. This is taking away parking spaces for patrons who use the Community Veterinary Hospital. Mr. Mazzullo said that this is an enforcement issue. The Board discussed putting up signs if this continues. Police Officer Jaeger said that he will relay this information to his office.
