# **CALL TO ORDER**

Mr. Mazzullo called to order the Regular Meeting at 7:38 p.m.

### **Old Business**

# 2. 904 Mamaroneck Avenue – Bus Stop in front of Excelsior Garage.

Mr. Mazzullo said that he will send an e-mail to Mr. Slingerland regarding the elimination of the bus stop.

#### Other

Mr. Mazzullo read a letter sent by Jeffrey Pottberg, 410 Beach Avenue, regarding trucks cutting through Beach Avenue. He requested that a "No Thru Trucks" sign be put up. A motion was passed by the Traffic Commissioners.

Mr. Brendolan noted that no sign has been put up.

Mr. Brendolan addressed The Realty Guild, LLC located on the Boston Post Road. He said the sidewalk was blacktopped at this location and should be investigated.

Mr. Mazzullo said that he will send an e-mail to Mr. Slingerland.

Mr. Brendolan said that each Traffic Commissioner should have a Code book.

Mr. Brendolan said that he will contact Ms. Sally Roberts.

Mr. Parisen noted that the new parking sign was put up for volunteer personnel on Sheldrake Place, and stated that the old sign has not yet been removed.

Mr. Brendolan confirmed that the new sign is up, and the old sign is up as well.

Police Officer Deshensky stated the sign on the railroad bridge does not match the pavement markings going northbound on Mamaroneck Avenue heading toward White Plains.

Mr. Albert and Ms. Lividini both agreed that the sign on the bridge and pavement markings are correct.

Mr. Porretto noted that on Mamaroneck Avenue at Old White Plains Road near Peter's Bakery and Tri-City Auto Parts, the bus stop was removed. There should be a sign that reads: "No Parking Here To Corner" starting from Peter's Bakery driveway to Old White Plains Road. Mr. Brendolan said that no sign is up.

### Other - April 12, 2012

Mr. Brendolan noted that the sign has not been put up in front of Sarah Neuman Nursing Home on Palmer Avenue. The Traffic Commissioners voted on this in 2011.

Mr. Brendolan commented that signs are not being put up, or removed. He offered to compile a list of outstanding agenda items that were voted on where signs are not up. Mr. Albert said that he will set up a status meeting with Mr. Slingerland including Mr. Mazzullo and Mr. Brendolan. Mr. Brendolan said that he will put together a list within the next few days.
