CALL TO ORDER

Mr. Mazzullo called to order the Regular Meeting at 7:35 p.m.

New Business

1. No Parking sign on Orienta Avenue.

The Board discussed the e-mail that was submitted by a resident requesting no parking on the portion of Orienta Avenue that connects with the sea wall. The resident stated that the roadway is narrow, and also noted that during the summer a car was parked for days in the road. Mr. Brendolan stated that the section of the roadway in question is 30 ½ feet wide which is adequate. No action was taken.

2. No Parking sign on corner of Mamaroneck Avenue and Old White Plains Road.

Mr. Porretto stated that this matter will be discussed at the next Board of Trustees Work Session.

Old Business

1. Proposal to limit parking at Ogden and Fayette Avenue

The Board discussed and agreed that when three cars are parked, it is difficult for trucks to exit. A photo was provided showing what is occurring. Mr. Brendolan recommended that a sign be put up that reads "No Stopping Here to Corner".

- ** MOTION PASSED UNANIMOUSLY.

2. Consideration of a double yellow line on Plaza Avenue between Waverly Avenue and Washington Street

Mr. Mazzullo said this is an enforcement issue. No action was taken.

3. Parking Lot behind Movie Theatre – Loading space for Red Plum Restaurant

The Board discussed and agreed that meter space number 355 will be used as a loading zone space for Red Plum Restaurant rather than meter space number 354. There was discussion that cars might take this space and park all day, therefore, the sign should specify *for trucks only*.

- ** ON MOTION OF MR. PORRETTO, METER SPACE NUMBER 355 ON PHILIPS PARK ROAD BEHIND RED PLUM RESTAURANT WILL BE CHANGED TO A LOADING ZONE SPACE. A 12 BY 18 INCHES SIGN TO READ: "LOADING ZONE, FOR TRUCKS ONLY".
- ** MR. BRENDOLAN SECONDED.
- ** MOTION PASSED UNANIMOUSLY.

Other

Mr. Brendolan stated for the October Agenda to add *No parking on both sides of the street on Royal Place*.

Mr. Porretto said the "No Parking Here to Corner" sign needs to be moved to the front of 115 Stoneybrook Avenue that extends to Osborne Avenue. He noted that the sign is down. Mr. Porretto said to refer to page 95 in the Code book.
