#### **CALL TO ORDER**

Mr. Porretto called to order the Regular Meeting at 7:30 p.m.

### **New Business**

1. Request for designated space for drop off and/or pick up of passengers in the area of Holy Trinity Church

The Board discussed and agreed there should be a drop off/pick up space in front of the church to accommodate those with disabilities, and the elderly.

- \*\* MR. BRENDOLAN MOVED TO APPROVE A 'NO PARKING SIGN' ON EAST BOSTON POST ROAD ON THE NORTH SIDE FROM DUBOIS AVENUE TO A POINT TWENTY (20) WEST FEET THEREOF FOR DROP OFF AND PICK UP ONLY
- \*\* SECONDED BY MR. SPEDAFINO.
- \*\* MOTION PASSED UNANIMOUSLY.
- 2. Allow parking on Seney between Walton and Claflin. Resident request.

No appearance by resident. In December 2010, no parking was voted on so that fire trucks, etc. can turn around in the street. Board discussed and agreed no action will be taken.

3. Change signs on Mamaroneck Avenue from Van Ranst to Sheldrake to ½ hour parking

The Board agreed that 90 minutes parking is too long and the time should be reduced. Mr. Porretto commented that there are motorists who park all day at this location.

Trustee Bermudez recommended 60 minutes parking rather than 30 minutes to allow sufficient time to shop in the local stores. The Board agreed that enforcement also is necessary. Trustee Bermudez said that he will speak with the Police Chief.

- \*\* MOTION PASSED UNANIMOUSLY.
- \*\* MR. BRENDOLAN MOVED TO APPROVE A SIGN THAT READS "60 MINUTES PARKING" ON MAMARONECK AVNEUE FROM VAN RANST PLACE TO SHELDRAKE AVENUE.
- \*\* MR. SPEDAFINO SECONDED.
- \*\* MOTION PASSED UNANIMOUSLY.
- 4. Move No Parking sign on Halstead Avenue south of Florence Street approximately 10 feet to pole

The Board discussed and agreed that the sign cannot be seen and needs to be moved onto the pole.

- \*\* MR. BRENDOLAN MOVED TO APPROVE THAT THE 'NO PARKING' SIGN ON HALSTEAD AVENUE SOUTH OF FLORENCE STREET BE PLACED ON THE POLE THAT IS TEN FEET AWAY FROM THE PRESENT SIGN.
- \*\* MR. SPEDAFINO SECONDED.
- \*\* MOTION PASSED UNANIMOUSLY.

#### **Old Business**

Mr. Brendolan said the sign is up on Royal Place and Hall Street, and the sign is up on Royal Place and Old Boston Post Road.

Bushes were replaced at Laura Joy Circle and line of sight is no longer an issue.

Resident of Orienta communicated that he wants to park on Depot Plaza and suggested a right turn lane on Hoyt Avenue to facilitate getting there more quickly. The Board discussed and determined no action will be taken. Mr. Porretto said he will contact the resident.
