## 1. 404 Maple Avenue

## 2. Stanley Avenue – One way Street from Mt. Pleasant Avenue to Maple Avenue

Ms. Susan DiCioccio stated that when on Stanley Avenue and turning onto Mt. Pleasant Avenue it is dangerous. There is a lot of fast moving traffic. Officer Jaeger agreed. Ms. DiCioccio said there have not been many accidents, but making the turn from Stanley Avenue onto Mt. Pleasant Avenue is challenging.

The Board discussed and confirmed there is much traffic in this area, and to change the section of the roadway to one-way on Stanley Avenue from Mt. Pleasant Avenue to Maple Avenue.

## 5. Speeding cars on Beach Avenue (Resident, Jeff Pottberg)

Village of Mamaroneck Board of Traffic Commissioners September 12, 2013 Page 2 of 4 A resident sent a note to the Mayor requesting that speed bumps be put down, or stop signs put up on Beach Avenue to slow down traffic that is cutting through the residential streets. The resident stated in his correspondence that there are many children in the neighborhood. The Board members agreed.

Mr. Porretto said speed bumps are prohibited on Village roads. The Board discussed and said it is an enforcement issue. Mr. Brendolan recommended that a site visit take place and to put on next month's agenda.

## 6. Replace No Parking sign at 408 E. Boston Post Road with 90 Minute Parking sign

The Board discussed and said it is warranted.
