CALL TO ORDER

Mr. Porretto called to order the Regular Meeting at 7:32 p.m.

Mr. Porretto welcomed new Board member Jack Yannuzzi

OLD BUSINESS:

1. Speeding cars on Beach Avenue (Resident, Jeff Pottberg)

No action taken. Mr. Porretto will notify the resident.

2. Remind DPW to white out lines when putting no parking signs in

Reminder: DPW to white out lines on Valley Place when putting in "No Parking" signs.

3. Maple Avenue sign versus Code

Mr. Brendolan stated the sign reads correctly but the Code needs to be changed. Tickets issued to the resident were given according to what the Village Code stated.

Mr. Brendolan moved to rescind three-hour parking from 9 AM to 5 PM Monday-Saturday in the Code book on page 134. Change Code to read: Three-hour parking from 9 AM to 5 PM Monday-Friday on the east side of Maple Avenue between Stanley Avenue and Bishop Place, seconded by Mr. Yannuzzi.

NEW BUSINESS:

1. Rescind parking on north side of Cortlandt Avenue from Fenimore to dead end of Cortlandt. Allow parking on south side of Cortlandt

Ms. Nikica Rendic appeared and stated that parking on the street should be reversed from the right side to the left side of the street.

The Board members discussed and determined it was appropriate to make the change.

Mr. Brendolan moved to rescind parking on the right side of Cortlandt Avenue from Fenimore Road to the driveway entrance on Cortlandt Avenue, seconded by Mr. Spedafino.

VOTE: 4-0

Mr. Brendolan moved to approve parking on the left side of Cortlandt Avenue from Fenimore Road to the driveway entrance on Cortlandt Avenue, seconded by Mr. Spedifino.

VOTE: 4-0

2. Union Avenue - extend 90 minutes parking

The Board discussed and agreed to the extension of time on Union Avenue between Anita Lane and Ward Avenue.

On motion of Mr. Spedafino, seconded by Mr. Brendolan, 90 minutes parking extended on Union Avenue from Anita Lane to Ward Avenue from 9 AM to 7 PM, seconded by Mr. Brendolan.

VOTE: 4-0

3. 131 Fenimore Road add No Parking sign 20 feet south of driveway

Ms. Nikica Rendic requested a 'No Parking' sign at this location. The Board discussed and agreed that a sign is necessary.

Mr. Spedafino moved to approve a 'No Parking' sign 20 feet south of the driveway on the east side of 131 Fenimore Road, seconded by Mr. Yannuzzi.

4. Remove parking on both sides of street at 355 Phillips Park Road

Mr. Brendolan stated that Phillips Park Road is 30 feet wide. The Board discussed and agreed that parking should be eliminated on a portion of Phillips Park Road.

Mr. Brendolan moved to approve two 'No Parking' signs be put up in the northerly direction on Phillips Park Road from 109 Spencer Place, 125 feet north to 355 Phillips Park Road, and in the southerly direction on Phillips Park Road from 109 Spencer Place, 83 feet south to the rear of the building driveway, seconded by Mr. Spedafino.

VOTE: 4-0

5. Add handicap parking space to Palmer Terrace

The Board discussed and agreed that a handicapped parking space should be added by units 704 to 709. On the left-hand side are units 705, 707 and 709, and on the right-hand side are units 704, 706 and 708.

On motion of Mr. Yannuzzi, seconded by Mr. Brendolan, one handicapped parking space to be added on Palmer Terrace between units 704 and 709.

6. Request for 15-Minute Parking on eastbound side which is in front of stores from Fenimore Road onto Palmer Avenue at #384.

Mr. Porretto said a site visit will take place and to put on next month's agenda.

OTHER

- Mr. Brendolan stated a yellow line needs to be painted on Hoyt Avenue from Mamaroneck Avenue to Fenimore Road.

- Mr. Yannuzzi stated that on the stop sign on Fenimore Road at Hoyt Street to add a sign reading 'Oncoming traffic does not stop' on the same pole as the stop sign.

- Mr. Yannuzzi stated on Halstead Avenue at Jefferson Extension that a sign reading 'Oncoming traffic does not stop' to be added on the stop sign pole and put underneath the stop sign.

- Double yellow lines needs to be painted on Fenimore Road from Prospect Avenue to the Boston Post Road.

- Stop Sign on Tompkins Avenue at Melbourne Avenue

Mr. Yannuzzi moved to approve a 'Stop' sign be installed on the west side on Tompkins Avenue at Melbourne Avenue, 20 feet from the corner thereof. Add a sign on the same pole to read 'Oncoming traffic does not stop', seconded by Mr. Spedafino.
