### **CALL TO ORDER**

### **New Business**

Change sign on Gertrude Avenue to allow right turn on red during non-school hours.

The Board members discussed and agreed that the sign should be changed to read No Turn on Red on School Days between the Hours of 7:00 a.m. and 4:30 p.m.

Mr. Porretto said that there was a complaint regarding no turning on red at the intersection of Mamaroneck and Halstead Avenues. It was noted that Halstead Avenue traffic backs up. The Board discussed the bus stop at that intersection and the hazardous condition when a motorist goes around a bus to make the turn. No action was taken.

#### **Old Business**

Mr. Porretto reported the following:

The County removed the bus stop in front of the Excelsior Garage.

Lines were painted on the pavement at 930 Mamaroneck Avenue.

Signs on the Boston Post Road are up by the veterinarian's office.

The sign at Laura Joy Circle is still blocked by overgrown shrubs.

Mr. Brendolan said the sign on Osborn and Harrison Avenues needs to be changed to a 'No Stopping' sign. Mr. Porretto said he will follow up.

Mr. Porretto said he will follow up on the two sign poles to be put up on Prospect Avenue and Library Lane.

Ms. Lividini reported that the Speed Limit sign at Palmer Terrace is not up. Mr. Porretto said he will follow up.

Ms. Ybarra discussed traffic congestion by Daniel Warren School.

Mr. Brendolan remarked that the No Left Turn sign at the corner of Keeler Avenue and the Boston Post Road should be put on the Stop sign pole.

The No Left Turn sign from Wagner Avenue to the Boston Post Road should be put on the Stop sign pole.

Mr. Porretto stated that he asked Ms. Roberts to update him on action taken by the Board of Trustees regarding Traffic Commission matters. Trustee Bermudez said that he too will note actions.
