## **CALL TO ORDER**

Mr. Porretto called to order the Regular Meeting at 7:19 p.m.

### **New Business**

### Middle School traffic, Hommocks Road

Ms. Susan McCance, resident of Oak Lane, Larchmont, appeared and discussed Oak Lane roadway and parts of it that are not accessible. She said that at the end of the road when turning onto Hommocks Road it is difficult. Ms. McCance said that 4 and 8 Oak Lane have foliage from their properties on the roadway that has narrowed the driving lanes. She asked that the Village visit the site, and also to contact the homeowners.

Mr. Porretto said the Building Department should be contacted. Trustee Bermudez said he will advise the Village Manager.

Mr. Porretto said they will go to the site before the next meeting. The resident was satisfied.

# Palmer Avenue and Fulton Road – No Parking Here to Corner (resident)

Mr. Porretto said he went to the location.

She noted that the sign also is down. She requested that a 'No Standing' sign be put up. The Board discussed and agreed.

On motion of Mr. Yannuzzi, seconded by Mr. Brendolan, a replacement sign to read: 'No Standing' to be installed on the northeast side of Palmer Avenue between Fulton Road and Rockland Avenue. Motion passed unanimously.

## No Standing Sign – 914 Palmer Avenue

The Board members discussed 914 Palmer Avenue at Fulton Road and agreed that a 'No Standing' sign should be put up 18 feet from the corner of Fulton Road to 914 Palmer Avenue.

On motion of Mr. Yannuzzi, seconded by Ms. Ybarra, a "No Standing" sign to be installed from the corner of Fulton Road 18 feet thereof in front of 914 Palmer Avenue on the northeast side. Motion passed unanimously.

## **Stop signs on Prospect Avenue at Maple Avenue (resident)**

The Board discussed and agreed no action will be taken. Mr. Porretto said the resident will be notified.

### No Parking sign on Park Avenue at Florence Street

Discussion followed. It was noted that the curb is bad at this location and that a 'No Standing' sign for 60 feet clearance should be put up from Park Avenue to 356 Florence Street.

On motion of Ms. Ybarra, seconded by Mr. Brendolan, a 'No Standing' sign to be installed in front of 356 Florence Street sixty feet from the corner of Park Avenue on the south side. Motion passed unanimously.

### **Other**

Ms. Ybarra discussed the light on the corner of Munro and Rockland Avenues. Mr. Porretto said a site visit will take place before the next meeting. To be placed on the next meeting agenda.

Mr Yannuzzi discussed 'No Turn on Red' at various intersections throughout the Village. He said at Palmer Avenue and Fenimore Road the No Turn on Red should apply only between 7 AM and 4:30 PM. The Board agreed that it was a valid request.

On motion of Mr. Yannuzzi, seconded by Ms. Ybarra, the "No Turn on Red' sign to be replaced with a sign to read: 'No Turn On Red from 7AM to 4:30 PM' on all four corners. Motion passed unanimously.

Mr. Yannuzzi discussed flashing lights from the schools that flash when schools are not in session. The Board discussed and determined the units could be malfunctioning. Ms. Apuzzo, resident, said it is annoying as she has a light flashing toward her unit off of Palmer Avenue on non-school hours and this needs to be looked into.
