CALL TO ORDER

Mr. Yannuzzi called to order the meeting at 7:38 p.m.

Old Business

No old business.

New Business

1. Short Street No Parking (Fire Department) - Stoneybrook

Mr. Brendolan said that the Fire Department wants one parking spot removed as the trucks can not maneuver the turn well.

Motion

On motion of Mr. Brendolan, seconded by Mr. Figliomeni, on the north side of Stoneybrook a No Parking sign be put up 45 feet from Osborn Avenue to a point 121 feet east to driveway at 1410 Stoneybrook Avenue. No parking between signs with arrow pointing to the right. Motion passed unanimously.

Mr. Yannuzzi said that another sign be put up with arrow pointing to the left.

Motion

On motion of Mr. Brendolan, seconded by Mr. Figliomeni, a No Parking sign be installed on Stoneybrook Avenue 15 feet to the right of the hydrant with arrow pointing to the left. Motion passed unanimously.

2. Move the sign on Osborn Avenue

The Board discussed and agreed the sign should be moved.

Motion

On motion of Mr. Brendolan, seconded by Mr. Figliomeni, the existing sign on Osborn Avenue "No Parking Here to Corner" be moved 10 feet to the left. Motion passed unanimously.

3. 572 Van Ranst Place – No Parking

Mr. Parisen stated that this is his property. He said that vehicles parked in the roadway partially park in front of his two-car driveway. He said the types of vehicles vary, and that it is difficult at times for him to get in and out of his driveway. He suggested that the 90 minutes parking sign be replaced with a sign to read: No Parking Anytime. The Board discussed and agreed it was a valid request.

Motion – No Parking Sign

On motion of Mr. Parisen, seconded by Mr. Figliomeni, the 90 Min. Parking sign at 572 Van Ranst Place be removed and replaced with a sign to read: No Parking Anytime. Motion passed unanimously.

4. 933 Mamaroneck Avenue – Eliminate Parking

The Board members discussed traffic issues that are occurring at this location that also extend up to the driveway of Harvest Market at 955 Mamaroneck Avenue. Mr. Tannenbaum said Mamaroneck Avenue is a County Road. Mr. Yannuzzi said he will notify the Village Manager of the hazardous conditions. No action taken.

5. Plaza Avenue and Madison Street – Stop Sign

The Board members discussed. Mr. Yannuzzi said there is no place to put an additional sign. Mr. Tannenbaum stated that when there are too many signs on a pole, the signs are not noted that well. No action taken.

6. Cedar Street – Move sign back

Mr. Brendolan said off Jefferson Avenue, the No Parking Here to Corner sign is too far from the corner and recommended that it be moved. He presented a diagram for the Board to review. The Board members discussed and agreed.

On motion of Mr. Brendolan, seconded by Mr. Figliomeni, the No Parking Here to Corner sign on Cedar Street off Jefferson Avenue be moved to a point 40 feet back to the corner of Jefferson Avenue. Motion passed unanimously.

Other

The Board members all agreed that the Traffic meeting start at 7:30 p.m. going forward.

The Board members requested that their Trustee attend their meeting for them to get a status on motions passed, as well as to gain the Trustee's insight on various traffic issues.

Mr. Yannuzzi requested that any Board member who cannot attend the meeting to let him know via e-mail: jackyannuzzi@gmail.com, or Elena DeCunzo in the Village office in advance of the meeting. Upon learning availability of members, the Chairman will determine if a meeting should be canceled.

Mr. Yannuzzi discussed the 24/7 flashing lights on Palmer Avenue at Sarah Neumann and the condominiums. It is distracting and interferes with ones' sleep. Mr. Yannuzzi said he will contact the Village Manager concerning reprogramming the light timer.

The taxi stand at the train station was discussed, and the option to remove the taxi parking spaces. Officer Valente said the taxis do not park in the designated spaces. If they do, it necessitates their backing out which could create an inconvenience and lost time especially when there is traffic. He said the overflow of cars and taxis also creates congestion for vehicles driving by the area. No action taken.

Mr. Figliomeni requested a site visit on Florence Street from Park Avenue to Keeler Avenue as there is much congestion especially between the hours of 2:30 p.m. and 3:30 p.m. weekdays. Put on April agenda.

Mr. Figliomeni suggested putting up a stop sign at Andrew Street and Louise Street near I-95 and the Shell station. The board members said they will go to the location to review. Put on the April agenda.

Mr. Brendolan said at 356 Florence Street near Park Avenue, there are parking issues and a No Parking sign should be put up. Put on April agenda.

Mr. Brendolan said at 417 Florence Street the No Parking sign should be changed to a No Stopping sign.
