Mr. Yannuzzi called to order the meeting at 7:33 p.m.

Mr. Yannuzzi welcomed Brian Kerr to the Board

Mr. Yannuzzi met with the Village Manager and reported the following:

- Flashing light on Palmer Avenue corrected
- Fenimore Road and Hoyt Avenue sign up
- Halstead Avenue at Jefferson Avenue sign up
- Club Car Parking MTA responsibility

New Business

1. North Barry to Mamaroneck Avenue – No Turn on Red (During Construction).

The Board discussed and determined that a sign should be put up during construction. Mr. Yannuzzi said after the construction is completed the sign should come down.

On motion of Mr. Tannenbaum, seconded by Mr. Mazzullo, a *No Turn on Red 7 AM to 9 AM*, and 3 PM to 6 PM Monday – Friday sign to be put up during the construction period. Motion passed unanimously.

2. No Left Turn onto Hillside Avenue from Mamaroneck Avenue – (Commissioner Tannenbaum).

Mr. Yannuzzi said he will e-mail the Village Manager requesting that a meeting be set up with personnel from the County Traffic department to discuss a study of the Mamaroneck Avenue roadway, and No Turn on Red at certain times. Put on the July Agenda.

3. Mamaroneck Avenue - Parking Spaces Earmarked for Motorcycles - (Officer Deshensky)

The Board agreed that certain small, compact size parking spaces within the Village suitable for Scooter/Motorcycle parking should be put in place. The Board recommended this change.

On motion of Mr. Kerr, seconded by Mr. Zagajeski, the Traffic Commissioners recommended that the Village Board look into assigning parking spaces suitable for scooter/motorcycle parking. Motion passed unanimously.

4. Taxi Stand - Village Code - (Officer Deshensky) -

Mr. Yannuzzi reported that Officer Deshensky took measurements of the taxi stand area. The Code needs to be changed.

Mr. Yannuzzi read into the record the existing Code. Mr. Kerr said Code 326.94 to be amended in accordance with provision 326.36.

On motion of Mr. Kerr, seconded by Mr. Zagajeski, Village Code 326.94 (Designated Taxi Stand) in accordance with provisions of 326.36 - Proposal: Location to read: Adjacent to the Station Plaza railroad platform starting at a point of 273 feet from the curb on Mamaroneck Avenue and proceed east to a point of 500 feet east thereof. Motion passed unanimously.

- 5. Right Side of Cortland Street No Parking (Resident) –
- 6. North side of Stoneybrook Avenue No Parking 45 feet from Osborn Avenue to a point 121 feet east to driveway at 1410 Stoneybrook Avenue. "No Parking Between Signs". (Fire Council)

Action already taken.

7. East side of Cedar Street at Jefferson Avenue – Move "No Standing Here to Corner" sign 18 feet forward northerly direction (Fire Council).

Action already taken.

8. Traffic light at the corner of Ogden Avenue and Waverly Avenue (resident)

The Board discussed and determined that this is an enforcement issue. No action taken.

Other

- Andrew Street and Louise Street 4-way intersection No signs. Put on July agenda.
- Mr. Kerr addressed Code 326.76 regarding direction of travel on Jensen Avenue at Keiler Avenue. Each corner had a stop sign. The word 'both' in Code 326.76 to be replaced with the word 'east'.

On motion of Mr. Kerr, seconded by Mr. Mazzullo, in Village Code 326.76, Jensen Avenue at Keiler Avenue, the word 'both' to be replaced with the word 'east'. Motion passed unanimously.

- Put on July agenda. 'No Parking Here to Corner' sign on Hunter Street at Park Avenue at the top of the hill. A site visit to take place before the July meeting.

Mr. Yannuzzi said he will discuss with the Village Manager the following:

- County Road study
- Additional No Left Turn signs on Mamaroneck Avenue i.e.., Hillside Avenue
- Motorcycle/scooter parking
- Keiler Avenue, Frank Avenue, and Boston Post Road area
