Mr. Yanuzzi called meeting to order at 7:20 p.m.

**New Business**

**Eliminate Parking on East Side of Second Street (Dead end)**

Mr. Yanuzzi and Mr. Brendolan visited the site and are concerned that a fire truck cannot get thru. Board discussed to eliminate parking on the east side of Second Street.

**On motion of Mr. Spedafino, seconded by Mr. Figliomeni, parking will be eliminated on east side of Second Street. Motion passed unanimously.**

**No Standing Sign at 417 Florence Street**

The Board discussed and agreed this is an enforcement issue and Police Department should be contacted. No action will be taken.

**Cedar Street No Parking Sign on Left Side (South)**

Board members stated no street signs have been put up and will let village manager know.

**No Parking at Brook Street and North Barry Avenue (Resident)**

Board discussed and agreed that 'No Parking' signs to be installed 30ft before Stop Sign on Brook Street and North Barry Avenue

**On Motion of Mr. Figliomeni, seconded by Mr. Brendolan, a "No Parking" signs to be installed 30ft before stop sign on Brook Street and North Barry. Motion passed unanimously.**

**Prospect Avenue and Maple Avenue – Yield to Pedestrians Sign**

The Board discussed and agreed a 'Yield to Pedestrians Sign' be installed on Prospect Avenue at the corner of Maple Avenue.

**On Motion of Mr. Brendolan, seconded by Mr. Mazzullo, a 'Yield to Pedestrians Sign' be installed on Prospect Avenue at the corner of Maple Avenue. Motion passed unanimously.**

**Travers Avenue and Villa Stop Sign (Referred back from BOT)**

The Board agreed they need clarification from Board of Trustees of exactly where the stop sign is located.

**Oriente Avenue from Rushmore to 360 Oriente add Sidewalk (Resident)**

Mrs. Cutler stated that several children take this route home from school, a sidewalk would make it safe. She also stated to have met with Mr. Slingerland. The Board agreed that a sidewalk would be more suitable for children safety.

**On Motion of Mr. Spedafino, seconded by Mr. Figliomeni, a sidewalk should be added on Oriente Avenue from Rushmore to 360 Oriente Avenue. Motion passed unanimously.**

**Old Boston Post Road Adjacent to McDonald's Sidewalk (Resident)**

The Board discussed and agreed this would also make it safer for children to walk home.

**On Motion of Mr. Brendolan, seconded by Mr. Spedafino, a Sidewalk should be added to Old Boston Post Road. Motion passed unanimously.**

**Other**

Mr. Brendolan discussed Short Street being difficult for a fire truck to drive thru. The Board decided a site visit should take place before the next meeting. To be placed on the next meeting agenda.
