Chairman Tannenbaum called to order the meeting at 7:30 p.m.

Mr. Tannenbaum welcomed new Board member Abby Roberts.

Mr. Tannenbaum said Dan Sarnoff will join the meeting to discuss emergency snow removal streets.

New Business

1. Grove Street/Wood Street Corner Intersection (Resident)

Discussions followed on one's line of sight at this location. Mr. Tannenbaum said a stop sign was added on Grove Street to slow down traffic. Mr. Mazzullo said it is hard to see on-coming traffic, and to turn out of Wood Street on to Grove Street when cars are parked to the corner.

The Board members agreed that a "No Parking Here to Corner" sign should be put up on Grove Street.

Ms. Roberts moved to approve, seconded by Mr. Figliomeni, a 'No Parking Here to Corner' sign on the south side of Grove Street, 15 feet west of Wood Street. Motion passed unanimously.

2. Carroll Avenue/Boston Post Road (Resident)

Mr. Tannenbaum said last year the Traffic Commission voted on a No Left Turn from Boston Post Road onto Carroll Avenue during certain hours. The Trustees received complaints from residents on this. This change was denied by the Trustees.

The Traffic board discussed additional alternatives. Mr. Tannenbaum suggested that the Board talk about this at an upcoming PTA school meeting. Mr. Figliomeni noted the area is congested and chaotic on school days. Children run into the road unattended to get to their parent's car.

3. Establishing Snow Emergency Streets

Mr. Dan Sarnoff joined the meeting to discuss a plan to designate certain streets to be cleared first of snow, and parked cars must be moved off those designated streets during snow emergencies. A list of proposed snow emergency streets was provided for discussion. The designated roadways will be plowed first. The arterial roadways will allow one to gain easier access to major facilities such as hospitals, major highways, etc. After the announcement has been made, cars parked on the designated snow emergency streets will be towed. Mr. Sarnoff said the area spans from Mamaroneck Avenue between the Post Road and the I-95 Bridge. Mr. Sarnoff said the Board of Trustees will consider this on February 22nd.

Mr. Tannenbaum said Ms. Westrup sent a note that North Barry Avenue should be considered. After discussion, it was determined that many of the homes on North Barry Avenue have good size driveways to park their vehicles.

Mr. Tannenbaum said that he would like to learn how the Snow Emergency announcement will be made known, and also how much time a resident will have to remove their vehicle from the roadway to avoid being towed. Mr. Sarnoff said he will get that information.

Mr. Tannenbaum said on Fenimore Road by the apartments, and Boston Post Road in the vicinity of the high school where the apartments are situated should not be included.

Mr. Zagajeski moved to exclude the following areas from the list of snow emergency routes: Boston Post Road westward from Rockland Avenue to Richbell Road and Fenimore Road, both sides, from Palmer Avenue to Boston Post Road, seconded by Mr. Figliomeni. Motion passed unanimously.

Mr. Tannenbaum said that after the meeting on February 22, the Traffic board would like a list of designated streets.

Mr. Sarnoff left the meeting at 8:19 p.m.

Other

- Ms. Hohlweck will follow up on name plates for board members. Update: 2/12: Plates will be available for the March meeting per Sally Roberts.
- Mr. Tannenbaum asked that the board members contact Ms. Hohlweck directly with any changes to the previous month's minutes prior to the upcoming meeting so that the minutes can be approved and voted on. Her e-mail is anneholt1@aol.com.
- Mr. Tannenbaum asked that the board members think about solutions regarding trucks that are hitting the railroad bridge. Mr. Mazzullo offered suggestions to paint the bridge a color that stands out. He also suggested adding strips on the edges of the bridge. Put on March agenda.
- Mr. Tannenbaum suggested that Hunter Street and Park Avenue be revisited to put up signs to read: No Parking Here to Corner. This was previously on the agenda in 2015. Put on March agenda.
