# DRAFT VILLAGE OF MAMARONECK BOARD OF TRAFFIC COMMISSIONERS THURSDAY, JANUARY 14, 2016

Chairman Tannenbaum called to order the meeting at 7:30 p.m.

# **Old Business**

# 1. Street Parking at 1415 & 1425 Halstead Avenue – Resident concern discussed at the December meeting.

Mr. Tannenbaum said the resident's neighbor is a renter who has a large vehicle and parks too close to resident's driveway obstructing views when driving out to the street. Mr. Kerr said the location is between Fourth Street and Hunter Avenue. Mr. Tannenbaum stated that this situation occurs on various narrow streets within the Village. He said that he will try to get the owner's phone number to discuss the tenant's parking. No action taken.

## **New Business**

# 1. 519 Carroll Avenue – Resident concern about parking too close to driveway and directly across the street making it difficult to exit (see attachment)

Mr. Tannenbaum said the next door neighbor to the resident has put down raised cobblestone on the driveway which is a hazard. Mr. Tannenbaum said when driveways are flared near the road, it is hard to determine where the property line ends. He said the driveway installer should not have done this type of work. The Board members concurred that the resident should speak to the neighbor suggesting that they remove the raised stone, and discuss parking too closely to the resident's driveway. No action taken.

### 2. Prohibition of following overnight parking on Waverly Avenue

Waverly Avenue South 9 p.m. to 6 a.m. all days from Fenimore Road to Concord Avenue – this has been asked to be looked into by Rose Sestito, due to the changes when TJ Milo built his buildings.

The Traffic Commissioners received a recommendation for no parking on the entire street of Waverly Avenue. The Board discussed, and disagreed with the recommendation to eliminate parking on the entire street. No action taken.

# 3. Traffic light at Mamaroneck Avenue and Hoyt Avenue – complaints from residents.

Mr. Tannenbaum said the red light for on-coming traffic is delayed at the Hoyt Avenue and Mamaroneck Avenue intersection. There is no notification for motorists. He said a left hand arrow going north on Mamaroneck Avenue is a solution, and that an arrow is better understood than putting up a sign. He stated that the height of a vehicle can impact ones' ability to read signs. Discussion followed and it was agreed that there be notification for motorists.

On motion of Mr. Kerr, seconded by Mr. Figliomeni, a letter to be sent to Village Manager recommending a left-hand arrow in the northerly direction on Mamaroneck Avenue at Hoyt Avenue or a sign indicating a delayed red light. Motion passed unanimously.

# **Other**

Ms. Wenstrup stated that a neighbor spoke with her regarding the intersection of Orienta and Rushmore Avenues. She said the added signage under the stop sign on Fenimore Road and Hoyt Avenue informing drivers that "Oncoming Traffic Does Not Stop" is helpful. She requested that similar signage be added to the two Stop signs at the intersection of Orienta and Rushmore Avenues. The Board members discussed and agreed that it is a valid request.

Ms. Wenstrup, seconded by Mr. Kerr, moved to approve a sign added to the Stop sign on Orienta Avenue to read: On-coming traffic does not stop", and a sign to be added to the Stop sign on Rushmore Avenue "On-coming traffic from right does not stop". Motion passed unanimously.

## **Minutes**

#### 1. December Minutes

On motion of Mr. Zagajeski, seconded by Mr. Wenstrup, the minutes of the December 2015 meeting were approved as submitted. Motion passed unanimously.
