Chairman Tannenbaum called to order the meeting at 7:35 p.m.

**New Business**

**1. 'No Parking' Corner Heathcote and 438 Stanley Avenue**

Mary Marchiselli, Stanley Avenue resident, appeared and stated that she has difficulty exiting her property and inquired if a parking space could be eliminated. There are visibility issues when going out onto the roadway from her driveway. She said that there are commercial trucks parked in the road.

Ms. Marchiselli stated also that motorists turn around in her driveway. Her house is the first house on the left after the apartment building.

Ms. Roberts suggested that a sign be put up in the road 'Compact Cars Only'. Mr. Mazzullo said that this type of sign cannot be put up on Village roads. This signage is used in parking lots.

Mr. Tannenbaum said that he is reluctant to take away Village parking spaces.

Mr. Tannenbaum said a site visit will take place before the next meeting.

**2. 351 Palmer Avenue School Bus Pick Up and Drop Off**

Mr. Tannenbaum said a resident wrote to the Village regarding his two handicap children who are picked up by a mini bus at this address. The Board was sympathetic for the family not

having adequate space for the bus to pick up the two children and their equipment, and agreed that action should be taken right away.

Mr. Tannenbaum said a handicap parking sign would allow any handicapped motorist to park in the spot and it would not work in this instance. He said the Village Board would have to pass an Ordinance. A special Ordinance passed could be rescinded at any time, i.e., should the family move away.

It was agreed that a custom sign be created for a handicap pick-up zone. This would cover the resident's driveway and six feet beyond the sign pole. Times discussed were from 6 a.m. to 8 a.m. and 2 p.m. to 4 p.m. on school days, and to paint lines on the road.

On motion of Mr. Mazzullo, seconded by Mr. Kerr, a custom sign for a handicap pick-up/drop-off zone be installed in front of the driveway at 351 Palmer Avenue westbound covering the width of the driveway and six feet east from the pole with hours posted as follows: 6 AM to 8 AM, and 2 PM to 4 PM on school days. Lines to be painted on the roadway. Motion passed.

### **3. 370 Palmer Avenue - Safety Issue**

This matter was discussed. No action taken.

### **4. Parking Time Limits on Nine Acres Lane**

After a brief discussion, Mr. Tannenbaum said a site visit will take place before the next meeting. The location is Nine Acres Lane and Orienta Avenue.

Put on October agenda.

### **5. No Parking 25 feet to Corner on Hall Avenue to Orienta Avenue**

This matter was previously discussed. Mr. Tannenbaum said he will e-mail the Chief.

### **6. Traffic Light at Hoyt Street and Mamaroneck Avenue**

Mr. Tannenbaum discussed the traffic light on Mamaroneck Avenue and Hoyt Street. It was suggested that a left-hand turn arrow in the westerly direction be added onto the traffic light on Mamaroneck Avenue and Hoyt Street. The Board agreed.

On motion of Mr. Kerr, seconded by Mr. Figliomeni, a left-hand turn arrow be put on the traffic light in the west bound direction on Mamaroneck Avenue and Hoyt Street. Motion passed.

## **Other**

### **- Bridge at Train Station Hit by Trucks and Board's Suggestions to Deter Future Hits**

The Bridge by the station was discussed. Yellow and black striping around the bridge tunnel alerting motorists of a low Bridge was recommended.

Officer Nadolske said that strikes to the Bridge continue on a weekly basis.

The Board members agreed that action needs to be taken soon. Mr. Tannenbaum said the Village would need to contact the MTA to discuss solutions.

On motion of Ms. Roberts, seconded by Mr. Kerr, the Traffic Commission supports and requests a follow through by the Village to contact the MTA on solutions to reduce hits to the Bridge, and to put yellow and black striping around the Bridge tunnel to alert motorists of the low Bridge. Motion passed.

- Mr. Tannenbaum said a laptop would be useful for traffic meetings to view Village street maps on the large screen in the courtroom. Ms. Hohlweck said she will contact Elena in the office.

- Ms. Hohlweck said she will contact Elena regarding having a Trustee attend the next Traffic meeting as discussed, and requested.
