Chairman Abby Roberts called to order the meeting at 7:32 p.m.

**Old Business**

**1. Light at Palmer Avenue and Richbell Road**

Ms. Roberts stated that this location is not within the Village's jurisdiction. No action taken.

**2. Traffic Study Visuals**

Mr. Sarnoff said that the traffic study was finalized last year. Traffic was evaluated near schools as part of the study.

Ms. Purdy suggested that a subcommittee be formed to review the traffic study findings. The subcommittee will prepare a preliminary report and present to the Traffic Commission. Trustee Lucas mentioned that minutes will need to be taken for this meeting. The following Board members volunteered to be on the subcommittee: Shannon Purdy, David Salko, Brian Kerr, and Ed Zagajeski. Put on April agenda.

**3. Beach and Tompkins Lights**

Mr. Sarnoff said he will follow up with Con Edison. Due to the recent storms, Con Edison did not get to this work. Put on April agenda.

Mr. Sarnoff stated that he will provide this information at the April meeting.

### **Other**

- Mr. Sarnoff said that there have been discussions about backing in to park on Mamaroneck Avenue. He noted that there are many accidents when backing out of parking spots. Backing in to park will work for the 200 to 400 blocks on Mamaroneck Avenue. On the 100-block, the roadway is too narrow. He said that a notice for this work was sent to approximately 200 engineers and to date they have gotten back 9 responses on their Request for Proposal (RFP). Put on April agenda.

- Trustee Lucas said at the Parks Commission meeting it was announced that soccer season will soon begin at Harbor Island. A request was made to eliminate parking on the road between the east and west basin parking lot. Mr. Keck suggested also to eliminate roadway parking behind the sewage treatment plant. Mr. Sarnoff said he will speak to Barry Casterella. Put on April agenda.

- Trustee Lucas stated that the Cortlandt Avenue parking matter will be on the BOT work session agenda for March 26. Discussion will be on parking that has changed over the years from the north side to the south side and then changed back. Arguments had been heard at Traffic meetings by building residents from both sides of the street. It was suggested that a building representative for each of the two buildings be identified and contacted.

- Mr. Kerr asked about the tree on Keeler Avenue that was damaged during the recent storms and that is leaning on power lines. Trustee Lucas stated that Con Edison handles that type of work. When the power is turned off to take down the tree, 1000's of residents will be impacted. Mr. Sarnoff said that this power line is a primary line and there are two trunk lines. Taking down the tree can be more dangerous. Con Edison will evaluate.

- Ms. Purdy addressed Village crash data. She said this data will be useful for placement of signs. Mr. Sarnoff said this information is with local law enforcement who go to the accident site. Mr. Sarnoff addressed red light cameras and said in NYS they are in use by cities of one million or larger.

- Ms. Roberts talked about speeding and crashes on the Boston Post Road, and in the area of the Ferndale shopping center. This area to be looked at before the next meeting. Put on April agenda.

- Trustee Lucas said she was contacted by a local boy scout who has an interest in traffic matters in the Rye Neck School district and is making this his community project. This project will be a preliminary step to his earning Eagle Scout rank that involves extensive work in planning,

organizing and managing a project. The Board welcomed this initiative and looks forward to having the boy scout come to a meeting.
