The meeting was called to order at 5 p.m.

Public Hearing - Proposed Marion Sanitary Code Regulation "Restricting the Sale of Tobacco Products and Nicotine Delivery Products".

The public hearing notice was read into record by Mr. Johnson, Chairman. Mr. Collett, Director of the Cape Cod Regional Tobacco Control program reviewed discussions with the Board about the possibility to increase the legal age to sell tobacco and nicotine delivery products in the town of Marion which would be in accordance with approximately 90 other communities that have done so in MA. They have also discussed the prohibition of sale of blunt wraps which are primarily used as drug delivery devices by the users and sold in various flavors. He commended the Board on their decision to consider the adoption of these two provisions to their regulations along with the inclusion of prohibition on the use of electronic cigarettes in places that already prohibit the use of other nicotine delivery and tobacco products such as indoor public places and all workplaces which is consistent with MA state law since July 2004. Mr. Johnson asked if there was anyone present to speak in opposition to the Marion Board of Health regulations. There were none so Mr. Johnson moved to adopt the two provisions, prohibiting smoking in workplaces and public places and the regulation of the Marion Board of Health restricting the sale of nicotine delivery products to youngsters under 21 effective March 1, 2016 and Mrs. Dunn seconded. VOTE: 3-0-0
