Master Plan – Discussion Open Space and Recreation, Cultural Resources

Town Planner Ken Buckland summarized the September 5, 2016 commentaries for Planning Board members regarding SRPEDD's Draft of the Marion Master Plan.

Mr. Buckland noted that there were differing opinions on the position of a conservation agent. After discussion, it was decided that it was probably best not to have this included in the Master Plan at this time. The decision could be presented to a new group to evaluate the necessity of an agent. It was also noted that a consultant could be hired as needed.

Margie Baldwin commented that the Town of Rochester has a part time conservation agent who has been very effective in the position.

Swapping current properties at risk with current open space – it was noted that valuing land can be a complex process.

Chairman Lane noted that it would be desirable to have comments from the advisory groups by September 20th; advisory group comments and the planning board comments will be incorporated with Mr. Buckland's recommendations. It is anticipated that SRPEDD will have a revised plan by the end of October.
