Public Hearings

Request for Determination of Applicability 80 Foley Rd. (Richer School)

John Ghiloni, Director of the City of Marlborough Public Facilites Department requested permission to remove the large trees behind Richer School, approximately 15-20 feet away from the building. He would also like to cut the brush back to the stone wall which is the property line and is approximately 20 feet from the building. Currently, a fence and the vegetation are only about 3-4 feet from the building. The tree removal is intended to help remove any hazards of trees falling onto the building, provide space so the roof can be repaired this summer, for egress safety, and to help dry up the back of the building a bit by creating additional circulation.

After some discussion, the Commission agreed that the removal of trees was ok, but, that minimal shrub removal should occur, no stumping is to occur and trash in the area is to be removed. In addition, the catchbasins on the site should be inspected to ensure they are working properly and are clean. The Commission closed the hearing and voted 6-0 to issue a Negative Determination of Applicability with the above noted conditions.

Notice of Intent (Continuation of Public Hearing)

431 Poirier Dr. (Marlborough High School)- The City of Marlborough DPW
Proposes to reconstruct roadways and parking and add water quality
improvements at the Marlborough High School property near wetlands. This item
was continued to the March 1st meeting as plans have not yet been finalized.
