Dear Mayor Vigeant:

As you are aware, the City of Marlborough ("City") will be transitioning over to an automated curbside solid waste and recycling program by July 1, 2012. As Chief Procurement Officer, I conducted a three (3) Request for Quotes process for the purchase or lease-purchase of the wheeled containers for both solid waste and recycling collection as outlined below.

The first process was conducted under State Contract FAC33. The City received one quote from E.L. Harvey & Sons, Inc. in the amount of \$1,575,000.00 with no option to leasepurchase the containers. The second process was conducted under State Contract FAC61DEP. The City received two quotes, one from Toter Inc. in the amount of \$902,685.00 with pricing for a 5-year lease in the amount of \$976,605.00 and a 7-year lease in the amount of \$1,011,045.00 and one from Cascade Engineering in the amount of \$896,385.00 with pricing for a 5-year lease in the amount of \$965,717.85 and a 7-year lease in the amount of \$1,006,097.75. The third process was conducted through an out-of-state cooperative purchasing program in which the City is a member. The City received a quote from Otto Environmental Systems, Inc. in the amount of \$895,965.00 with pricing for a 5-year lease in the amount of \$964,765.20 and a 7-year lease in the amount of \$1,001,244.72. In addition to offering the lowest price, Otto Environmental Systems, Inc. offers a 2% discount for early payment reducing the cost to purchase the containers to \$878,045.70. The City also has received a DEP grant to assist with purchasing or lease-purchasing the containers in the amount of \$100,000.00. If the City applies the grant to the purchase price from Otto Environment Systems, Inc., the outright purchase price would be \$778,045.70. The City has the option to apply the grant to a lease-purchase if the City wishes to pursue that option.

Page 2 Letter to Mayor – Procurement Options for Containers January 18, 2012

The quote proposals were reviewed by DPW Commissioner Ron LaFreniere. He made a spreadsheet dated 1/19/12 summarizing the terms and conditions of each quote, a copy of which is attached hereto. Whether the City is considering outright purchase or lease-purchase option, it appears Otto Environmental Systems, Inc. is offering the lowest price quote. The Commissioner recommends purchasing the containers outright if the City's free cash or undesignated stabilization funds would permit the outright purchase, thereby foregoing any additional costs incurred by the lease-purchase option. If the City decides to exercise the leasepurchase option, the lease payments would be made from the savings realized under the new agreement for collection services.

Although I believe the quote options pursued under state contract and the out-of-state cooperative purchasing program has resulted in competitive pricing, the City may exercise the option to issue an Invitation for Bid process, at its discretion. It is my understanding that the City's acceptance of the grant funding is time-sensitive. Additional information in this regard may be obtained from Commissioner LaFreniere.

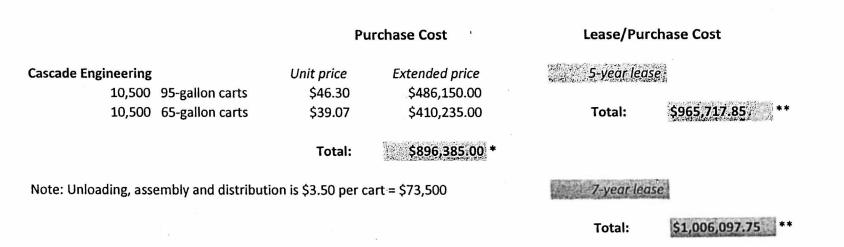

Attached is a letter from Richard Bennett, President and CEO for the Marlborough Savings Bank concerning his desire to operate the drive-through ATM at 81 Granger Boulevard on a 24 hour basis.

I bring to the City Council's attention that the process for issuance of the Special Permit to the Bank in 2009 included hearings and subcommittee meetings that resulted in a Special Permit that contained 32 conditions, including # 19b which addressed the authority under which the drive-through ATM will operate.

Condition 19b reads as follows:

"the operation of the drive-through ATM at the site shall be suspended from 12:00 Midnight to 5:00 AM; the City Council, after one year from the date when the drive-through ATM commences operations, may review and amend the hours of operation for the drive-through ATM."

As the Zoning Enforcement Officer for all Special Permits, I consider condition 19b as an open item that can be revisited, monitored and acted upon by the City Council <u>as an administrative matter</u> by referring to the Urban Affairs Committee for further discussion, followed by a vote of the full City Council.

Please refer to Urban Affairs at your earliest convenience. I am available for further discussion if necessary.

I would like to have the City Council consider increasing the hours of the ATM at 81 Granger Blvd to 24 hours/day. In the special permit order, under 19b it indicates that "the City Council, after one (1) year from the date when the drive-through ATM commences operations, may review and amend the hours of operation for the drive-through ATM".

Due to the ATM behind 166 Main Street not complying with the new ADA legislation which takes affect this March, it's important to increase the hours to 24 hours/day. Marlborough Savings has done everything possible to accommodate the neighbors including: eliminating certain lights around the perimeter, lowered the volume on the ATM, and had numerous discussions with vendors concerning snow plowing and trash pick-up.

Therefore, I would greatly appreciate it if the Council would take this issue up at their earliest convenience so that Marlborough Savings can remain competitive with all the other financial institutions.
