Re: Update - Emergency Notification System

Honorable President Pope and Councilors:

I want to update the Council on the implementation of our new emergency notification system.

At the end of June, I signed off on an agreement with Blackboard Connect, the vendor we chose to operate our system after vetting their product with other communities and meetings that involved my office, Police Chief Mark Leonard, Fire Chief Jim Fortin, Emergency Management Director Don Cusson, and Information Technology Director Mark Gibbs.

In summation, this web based system will allow the city to communicate important and vital information to our residents at a minute's notice via telephone, email, or text message without the need for the purchasing of any hardware or telecommunications equipment. Furthermore, this system allows us to communicate this same vital information to the businesses in our community who wish to be included.

Recently, we had in-house training sessions from Blackboard Connect and employees from the Police, Fire, Public Works, Recreation, and I.T. Departments were all in attendance in addition to staff from the COA, Library, Board of Health, and Emergency Management. The goal of this new system is to allow the city to more effectively relay information to our residents in times of major power outages, weather emergencies, road closures, and Amber and Silver alerts for example. Notifications can be distributed city wide, by ward or precinct, and even by street. Additionally, this system will allow us to easily expand our notifications to include nonemergency items like recreation and school events and other announcements.

The next step in this process to commence over the next several weeks is to allow residents to sign up on Blackboard's website to tailor their preferred methods of communication and allow them to customize which type of notifications they wish to receive (for example: a resident may prefer text notifications limited only to emergency notifications). The I.T. Department is currently configuring the web portal which will be featured on the City of Marlborough homepage that will allow residents and businesses to sign up and subscribe to our notification system.

At this point, the City is prepared is use this system in the event of an emergency. However it is incumbent that we continue to spread the word about this new system throughout our community so that our notifications are able to reach the highest number of residents and businesses.

I want to thank the Council for their patience throughout this process. I am very confident in this system and believe it will be a tremendous benefit to our departments as well as our residents.

To exemplify this, I have streamed lined the permitting process in my current job to expedite certain types of permits (shed, fences, etc.). This has helped to eliminate permit build up in the office and decrease the anxiety that the public sometimes experience when waiting for permits that are deemed "small jobs" in nature to them. I have also designed several informational handouts and inspection formats to assist both the public and the contractor in the inspection process.

But why I believe that I can better serve your community; just take a look at the communities that I have worked for and how that experience can benefit the City of Marlborough.

As the Building Commissioner in Hudson – I was involved in the additions to and fit up of the Digital plant (now Intel); various factory renovations; the construction of Wal-Mart and other similar projects during my tenure. My day usually started with meetings with architects and designers to help them get their projects off the ground. I know what has to be done to get commercial projects moving and that is experience that I can bring to your community.

### **SIGNS**

The Planning Board had the opportunity to ask Ms. Wilderman, Code Enforcement Officer, and Mr. Stephen Reid, Building Commissioner, a few questions regarding the ongoing prohibited signs. Ms. Wilderman explained that in the past few months her documented violations and the process it takes to just to send out the violations. She stated that of the 25 sign violations all but two have rectified the violation. She stated that under the sign ordinance she can assign a fine of \$50.00, but under the blight ordinance she can issue fine violations up to \$300 per day, per violation.

They also discussed the collection bins. Mr. Reid stated it was more of a site plan issue because of the location of the bins taking over parking spaces or sidewalk space. He stated that there were a few placed at Fuji Steakhouse, after calling the business owner, they were removed.

Mr. Fay expressed his concern that property owners who have been denied a variance are in violation of the sign ordinance with banners and other non-permitted signs. He also

expressed concern that a property owner who is denied a variance could sue the City for selective enforcement with the current level of enforcement of sign violations.

Mr. Reid stated that some violations are easier to resolve then others, especially when there is a contact person. He stated sometimes it's a new manager or the companies think that it's okay to place the sign after certain times. Ms. Wilderman stated that if there is a contact person for the violators it was much easier, but she stated that some signs (ex. Telephone poles and yard signs) do not have a local contact or you get answering services when you do contact them.

Ms. Hughes also stated that it may be possible to utilize the summer internship program and having an intern with a city employee pick up the illegal signs. It was also suggested that some of the members will use their cameras to take pictures of the illegal signs, then send the violations to Mrs. Lizotte and she will then forward them to Ms. Wilderman's office.

The Planning Board for the City of Marlborough met on Monday, June 18, 2012 in Memorial Hall, 3<sup>rd</sup> Floor, City Hall 140 Main Street, Marlborough, MA 01752. Members present: Barbara Fenby, Colleen Hughes, Sean Fay, Philip Hodge and Clyde Johnson. Also present: City Engineer Thomas Cullen.

On a motion by Ms. Hughes, seconded by Mr. Hodge, it was duly voted:

To move up sections 5 and 3.

### SUBDIVISION PROGRESS REPORTS

### City Engineer Update

Mr. Cullen stated that his assistant has met with the engineers at Mauro Farms and that they said the sewer issue was been resolved. He also stated that his assistant met with Howard Fafard of Fafard Development regarding several subdivisions, nothing that was discussed during that meeting has been completed on any of the subdivisions.

### **Blackhorse Farms**

Extension Request

Mr. Donald Seaberg is requesting on the developers behalf for a two year extension and also submitted a completion schedule for review.

On a motion by Ms. Hughes, seconded by Mr. Hodge, it was duly voted:

To send the extension request to the City Engineer for his review and to report back to the Board at the next meeting.

Mrs. Lizotte noted that the current extension will lapse prior to the next meeting.

On a motion by Mr. Fay, seconded by Mr. Hodge, it was duly voted:

To grant an extension of the subdivision approval of Blackhorse Farm until July 15, 2012.

Mr. Fay stated the he visited the subdivision earlier in the day and that the chain was still blocking access to the neighborhood. He noted that as a condition of their last extension that the Board insisted that the developer open up the development to the neighborhood and police illegal dumping as the problem was caused by their inaction. He also noted that simple tasks requested by the Board such as cleanup of debris, had not been completed. Mr. Fay suggested asking the City Solicitor for guidance concerning the Board's options other than pulling the bond for the Subdivision since it appears that none of the developer's previous representations have been sincere.

### Elm Farm Valley Estates

Plan of Acceptance Clarification

This subdivision is before the Public Services Committee for acceptance and while he was researching the correspondence, the City Solicitor noted that the plan of Acceptance was voted upon, however the date given in the acceptance letter to the City Council was not the corresponding date on the plan. Mrs. Lizotte noted that this was a scrivener's error.

To resolved the date discrepancy, both dates were included in a motion by Mr. Fay, seconded by Mr. Hodge, it was duly voted:

To send a favorable recommendation to the City Council to endorse the plan known as "Plan of Acceptance of Cleversy Drive and Easements, Marlborough, MA dated October 14, 2004 with the latest revision date of March 8, 2010".

City Council Request

The City Solicitor noted that while reviewing the acceptance plans, the City Council never requested a acceptance letter from the Planning Board. Mr. Rider is asking the Board to do a retroactive letter dating back to Jan of 2011.

Submittal & Decision

Mr. Zach Bemis presented the plan to the Planning Board. He stated that they are creating a new parcel to satisfy the abutting neighbor's complaints of adverse possession. Lot 18A will be reduced to 8,003 SF with 100 feet of frontage and not to be considered a building lot, Lot 18A will have 14,540 Sq Ft with 100 feet of frontage and Parcel A will have 6156 square feet with no frontage.
