Councilor Clancy reported the following out of the Personnel Committee:

Order No. 08-1001765 – Reappointment of Dr. Kevin Cozzi to the Board of Health for three years commencing on February 4, 2008 and terminating on February 7, 2011. **Recommendation of the Personnel Committee is to approve 3-0.**

Order No. 08-1001764 – Reappointment of Daniel C. Brogie to the Board of Assessors for a term of three years expiring on February 1, 2011. Recommendation of the Personnel Committee is to approve 3-0.

Order No. 08-1001760 – Reappointment of Mark Gibbs as Information Systems Director for a term of three years expiring January 1, 2011. Recommendation of the Personnel Committee is to approve 3-0.

Order No. 08-1001762 – Reappointment of Stephen F Reid as Building Inspector for a term of three years expiring February 1, 2011. Recommendation of the Personnel Committee is to approve 3-0.

Order No. 08-1001759 – Reappointment of Jean Peters to the Library of Trustees for a term of three years expiring February 1, 2011. Recommendation of the Personnel Committee is to approve 3-0.

Councilor Juaire reported the following out of the Public Services Committee:

Order No. 08-1001782 - Communication from the Commissioner of Public Works, Ronald LaFreniere, requesting that the Department of Public Works be authorized to remove snow and ice from the following private ways in accordance with the provisions of Chapter 225 of the Acts of 1943:

Recommendation of the Public Services Committee is to approve 3-0.

Order No. 08-1001789 — Application from Benjamin Smith of Tunison Smith Co. regarding sewer connection permit for Mauro Farm. Recommendation of the Public Services Committee is to approve with the conditions as recommended by Assistant Commissioner Doran Crouse:

- 1. The Sewer Connection Permit is limited to 11,880 gpd;
- 2. The Sewer Connection Permit shall lapse if the connection is not made within 18 months after the date of final approval;
- 3. If the total volume is not needed, the surplus shall be returned to the City of Marlborough.

Councilor Ossing reported the following out of the Finance Committee:

Order No. 08-1001768 – Transfer \$4,285.00 from Undesignated Funds to Elections Printing. The Finance Committee reviewed the Mayor's letter dated January 24, 2008 requesting a transfer of \$4,285.00 from Undesignated Funds to the Elections Printing account to cover the cost associated with programming the voting machines for the Presidential Primary election. The City Clerk informed the Finance Committee that an additional transfer will be required to cover the two Ward 5 elections. **Recommendation of the Finance Committee is to approve 5-0.**

Order No. 08-1001777 – Transfer \$6,000.00 from Undesignated Funds to Reverse 911 Support. The Finance Committee reviewed the Mayor's letter dated January 9, 2008 requesting a transfer of \$6,000.00 from Undesignated Funds to Reverse 911 account to accommodate an expansion of 12 additional service ports (3,500.00) and payment for the balance of the MassCall requirements from August (\$2,500.00) **Recommendation of the Finance Committee is to approve 5-0.**

Order No. 08-1001767 – Transfer \$130,649.98 from Reserve for Salaries to fund the FY08 Municipal Employee Association Contract. The Finance Committee reviewed the Mayor's letter dated January 24, 2008 to fund the FY08 Marlborough Municipal Employee Association contract in the amount of \$130,649.98. This money will be transferred from Reserve for Salaries to various salary account line items. **Recommendation of the Finance Committee is to approve 5-0.**

ORDERED: That Deborah A. Puleo's reappointment as City Collector effective February 1, 2008, **APPROVED**; adopted.

ORDERED: That City Council Order No. 06100-1337A, as adopted on November 6, 2006, and as amended on March 12, 2007, is hereby further amended by authorizing the Mayor, after having conferred collectively with two City Councilors appointed by the Council President, the Chief Procurement Officer and the Public Facilities Director, to have the exclusive authority to execute a binding agreement, for a period not to exceed a 5-year maximum term inclusive of any renewals or extensions of said agreement, with the selected supplier once pricing bids have been received and reviewed, as well as the exclusive authority to amend such agreement with regard to non-substantive issues and to report same to the Council, **APPROVED**; adopted.

ORDERED: That an oversight was made in the closing of the FY2007 books regarding funds in the amount of \$1,451,150.50 were not encumbered for the June 30th retirement fund payment and these funds were closed out at year end and became part of the free cash calculation, be and is herewith **REFER BACK TO MAYOR, COMPTROLLER AND AUDITOR AND TO BE PLACED ON THE FEBRUARY 11, 2008 AGENDA.**

SINCE THE COMPTROLLER WAS NOT PRESENT AT THE FEBRUARY 11, 2008 MEETING, THIS ITEM IS TO BE PLACED ON THE FEBRUARY 25, 2008 AGENDA; adopted.

ORDERED: That a part-time Senior clerk be dedicated to the Code Enforcement Office, **FILE**; adopted.
