#### **Technical Report**

Pursuant to Mass. Gen. L. Ch. 149, §§ 6 and 18A, it is the responsibility of the Department of Labor Standards ("DLS") to investigate occupational health hazards in the workplace, to recommend controls to reduce such hazards, and to assist counties and municipalities to comply with applicable safety and health laws, regulations, and recognized industry standards.

On March 30, 2016, Arthur Pennesi from DLS conducted an inspection of the crosswalks where Crossing Guards are stationed for the City of Marlborough Public and Private Schools to evaluate Crossing Guard safety. The Crossing Guards report to the Marlborough Police Department ("Respondent"). Recommendations are provided to prevent future injuries to crossing guards and students and are based on the Federal Highway Administration's Manual on Uniform Traffic Control Devices (MUTCD) and Massachusetts General Law. The Town is expected to apply DLS recommendations at all locations where crossing guards are assigned.

DLS identified conditions which place employees at risk of work-related injury or illness. DLS hereby issues a Written Warning and Order to the Respondent to correct those conditions in accordance with Massachusetts General Laws and Federal regulations. Respondent shall address the corrective measures outlined in the Conditions Requiring Corrective Action and Order to Correct. Respondent is advised to apply DLS corrective actions and recommendations as appropriate to other work locations within the municipality.

#### **Observations**

The City of Marlborough uses approximately four4 city employees to perform Crossing Guard duties. They all received a combination of classroom and hands on training prior to their job assignments and fall under the supervision and monitoring of Captain Paul E. Valianti of the Marlborough Police Department. They are given a Crossing Guard policy and procedures and go through hands-on training either with another crossing guard or the Captain in charge. Each Crossing Guard is issued an ANSI Class 2 retro-reflective vest and use gloved hands to provide stop signals to drivers. The DLS inspector recommends that each also be provided with a stop paddle. For assistance with aggressive drivers, Crossing Guards can submit the license plate, make of car and time of day and intersection to Captain Valianti at the end of their shift.

The crosswalks and signage at each of the manned and unmanned crosswalks for the Marlborough High, Middle school and two2 elementary schools were evaluated. The crosswalk for the Immaculate Conception and the Collaborative school were also reviewed. Recommendations for improvements or corrections for MUTCD compliance are shown below. They are summarized as follows:

All crossing guards should be provided with stop paddle signs to reinforce the high visibility vest and hand gloves to be seen and observed.

Immaculate Conception: The crosswalk needs the crosswalk sign from each approach with a diagonal arrow pointing to the crosswalk. One of the blinking 20 mph school speed limit lights did not appear to be working on the afternoon of the visit. Recommended is the optional sign: "Stop for pedestrians in the crosswalk state law" rectangular sign.

Collaborative School: located on a dead end street no crosswalks observed, no changes needed.

High School Crosswalk: needs the downward arrow pointing to the crosswalk from each North and South direction. Recommended is the optional stop for pedestrians in the crosswalk state law rectangular sign.

Whitcomb Elementary crosswalks near lights. Recommended is the optional sign: "Stop for pedestrians in the crosswalk - state law" rectangular sign.

Richer Elementary School: needs the down arrow at the crosswalk sign. Recommended is the optional stop for pedestrians in the crosswalk state law rectangular sign.

## **CONDITIONS REQUIRING CORRECTIVE ACTION**

Item 001:

Corrective Due Date: May 30, 2015

<u>Condition</u>: The crosswalk at the Immaculate Conception School heading East and West does not not have a "Pedestrian Crossing" sign required by the MUTCD 2009 edition for school cross walk markings.



Massachusetts General Law: MGL Ch. 149, section 6

Industry Standard: MUTCD Section 7B.12 School Crossing Assembly School Crossing assembly shall be installed at the school crossing and shall consist of a School (S1-1) sign supplemented with a diagonal downward pointing arrow (W16-7P) Section 7D.05 Operating procedures for Adult Crossing Guards. Adult Crossing Guards shall use a STOP paddle. The paddle shall be the primary hand-signaling device. The stop paddle shall be octagonal in shape. The background STOP face shall be red with at least 6 inch series upper case white letters with border. The paddle shall be at least 18 inches in size.

Corrective Action Required: Add a crosswalk and downward pointing arrows on the signs at the Immaculate Conception crosswalks. Provide the crossing guard with stop paddle. Determine if the school speed limit blinking sign works in both directions. One was blinking while the light going east to west on Washington Street did not appear to be blinking. Determine if this light is working correctly.

<u>Proof of Corrective Action</u>: Submit a photo showing that a "Pedestrian Crossing" sign is posted in both directions of approach to the crosswalk. Submit information that the blinking sign has been evaluated, and repaired, if necessary.



Franklikker / Franklikker 1 :

Condition: The crosswalk street signs at the Marlborough High School lacked the downward arrow pointing to the crosswalk required by the MUTCD 2009 edition for school cross walk markings. The crosswalk sign before the crosswalk should have the words ahead or 200 feet ahead added.



The crossing guard assembly at the crosswalk should include a downward arrow pointing to the crosswalk. The crosswalk approaching sign on the right should have the words ahead added below the sign.

Massachusetts General Law: MGL Ch. 149, section 6

<u>Industry Standard</u>: MUTCD Section 7B.12 School Crossing Assembly School Crossing assembly shall be installed at the school crossing and shall consist of a School (S1-1) sign supplemented with a diagonal downward pointing arrow (W16-7P)

<u>Corrective Action Required</u>: Add a crosswalk and downward pointing arrows on the signs at the Immaculate Conception crosswalks. Provide the crossing guard with stop paddle. For the crosswalk ahead sign add the word ahead or in 200 feet etc.

<u>Proof of Corrective Action</u>: Submit a photo showing that a "Pedestrian Crossing" sign is posted in both directions of approach to the crosswalk. Submit information that the blinking sign has been evaluated, and repaired, if necessary.



# CONDITIONS REQUIRING CORRECTIVE ACTION

#### Item 003:

Corrective Due Date: May 30, 2015

<u>Condition</u>: The crosswalk street signs at the Richer Elementary School at 80 Foley Road lacked the downward arrow pointing to the crosswalk required by the MUTCD 2009 edition for school cross walk markings.



The crossing guard assembly at the crosswalk should include a downward arrow pointing to the crosswalk.

Massachusetts General Law: MGL Ch. 149, section 6

<u>Industry Standard</u>: MUTCD Section 7B.12 School Crossing Assembly School Crossing assembly shall be installed at the school crossing and shall consist of a School (S1-1) sign supplemented with a diagonal downward pointing arrow (W16-7P)

<u>Corrective Action Required</u>: Add a downward pointing arrows on the signs at the Richer Elementary School crosswalks. Provide the crossing guard with stop paddle.

<u>Proof of Corrective Action</u>: Submit a photo showing that a directional arrow has been added to the "Pedestrian Crossing" sign.





Photo 1: Example of signs that can warn motorists that state law requires them to stop for pedestrians in the crosswalks (MUTCD Figure 7B-6)

<u>Recommendation</u>: Review the MUTCD for signs that could improve safety of Crossing Guards positioned in crosswalks.



At left shows a typical stop paddle, the white letters shall be retroreflectorized when used in hours of darkness.

- Conduct accident investigations and determine preventative strategies.

Dear Mayor Arthur Vigeant

My name is Andrew Tivnan; I live at 274 Wilson Street on the corner of Wilson and Hemenway Streets for the past 33 years. I would like to propose to your executive office a request to review a new street sign on Hemenway Street. The reason I would like for you to consider my request is to improve the safety and financial concerns for the City of Mariboro Massachusetts.

We have had re-occurring situations about a fire hydrants being struck 5 times over the past 19 years on his watch according to Dave Lavelle from Marlboro DPW. I believe there were two additional hydrants struck and damaged since 1983 as property owners at 274 Wilson Street. In addition, my property has incurred damages several times ripping up my lawn with several vehicles coming down on my property nearly hitting my home, my stone wall and destroying my mailbox(s) 4 times. Also, about 10 years ago I was nearly hit while shoveling around our front mailbox.

I spoke with Dave Lavelle DPW supervisor about the hydrant damaged from an accident on April 5, 2016. In conversation, Mr. Lavelle mentioned to me we need to figure out how we can prevent the hydrant(s) and my property from re-occurring damages.

Mr. Mayor, I propose for your consideration a new stop sign on Hemenway Street across from corner of Wilson Street. I have physically observed vehicles over the years turning this corner at excessive speeds of 40 plus MPH. This new stop sign would force motorist to stop and would slow the speeds down to 10-15 MPH while turning the corner onto Wilson Street and should eliminate future damages to water hydrants, personal property to my lawn and accidents costing many thousands of dollars to the city of Mariboro Ma.
