The stop sign at Shea Drive was taken down. This has made for a dangerous intersection since we cannot see the cars coming up the hill. And they drive up it very fast.

And now with the snow and the way it is plowed at the corner, the southbound lane of Bigelow Street is almost totally blocked.

Please reconsider these stop signs. My family has had a number of close calls due to this traffic pattern change.

As a person that uses this route often, I suggest removing the stop sign at Nashoba Street, which has clear sight of the Bigelow Street traffic, and putting a stop sign back at Shea Drive.

Dear Mark,

My name is Devan Tonelli, and I am the General Manager of New England Academy of Gymnastics, located at 894 Boston Post Rd. E. in Marlborough. I am writing because I am very concerned about the safety of the intersection at our gym. Our building is part of a busy commercial lot, across the street from Raytheon. Over the time that I have been with this company, I have dealt with a great deal of accidents that occur at this intersection. There have been about 5 just since the new year began.

Our gymnastics club services a great deal of children and families in the town of Marlborough. About 500 per week to be more precise. Many of the fore-mentioned accidents have involved our families and staff. There is a growing concern amongst our clients regarding the safety of this intersection. My fear is that it is only a matter of time before we are dealing with a fatal crash, possibly involving children.

I have voiced my concerns to some of your police staff on the scene at past accidents and was told that you would be a good person to inform of the situation. I would like to see if there are any possible action steps that can be taken in order to make this intersection safer for everyone. One thought that I have is to potentially add a turning lane going into our industrial park. We share our lot with about 10 other successful businesses so there is constant traffic coming in and out of our lot every day. I noticed that Raytheon has a turning lane going into their business with a green arrow at the light. Perhaps this is something that you could implement going into our lot as well? I am open to your thoughts and other options. My main goal is to improve the safety of our facility for our clients, and I am sure that the other businesses in our lot feel likewise.

Please let me know that you received this. If there is any other information or help that we can provide to you and your staff, we would happily cooperate.

## Chief(s),

At the last Traffic Commission meeting, Engineering was tasked with coming up with an alternative intersection configuration that would tend to eliminate the sweeping turning movement off Bigelow Street onto Elm Street. We have re-aligned the intersection and reduces the pavement to create more of a 90° turning movement off Bigelow Street.

If the Traffic Commission is in favor of this idea, we will mark it on the pavement so the Traffic Commission can field observe what the change will look like.
