

- 2. The Town's annual cat and dog rabies clinic will be held on Sunday, March 30, 2014 at 12 Noon at the Mattapoisett Fire Station. Please note that all dogs must be leashed and all cats be carriers. Licensing will be available for Mattapoisett residents. There will be a fee of \$12 for male or female and \$9 for spayed and neutered.

INCOMING AND OUTGOING CORRESPONDENCE

- Notice from Division of Marine Fisheries enhancing recreational saltwater fishing opportunities through improved public access. In order to do so they are funding a grant program in the form of a Request for Responses to municipalities based on the state Compass system.
- 2. Notification from Nstar that they intend to selectively apply herbicides along power line and natural gas rights-of-way that pass through the municipalities. The treatment is conducted as a component of an integrated vegetation management program that also utilizes mechanical and natural control techniques.
