## **Members in Attendance:**

The Chairman opened the Board of Health meeting at 6:30 pm.

#### 32 A Broken Tree Well Permit:

This is an application for private well construction permit.

Michael Curatola was present. This is for property located at 32 A Broken Tree Road. This is Map 10, Parcel number 21. The well is 120 ft. from Septic. It is 20 ft. to lot line. It is undeveloped on the other side. There is plenty of room. No sewer service.

# **Solid Waste Regulations:**

Tom Holder was present and was informed by the Health Agent the recommendations from the Board of Health.

This was further reviewed by the Board.

The Town is looking for a single stream to increase the recycling rate.

## **Independent Solid Waste Hauler Regulation:**

#### 32 Broken Tree:

Irrigation Permit for 32 Broken Tree. This was signed by Michael Heavey.

#### 44 Main Street:

The owner at 44 Main Street cleaned up the property. The Health Agent sent a letter thanking them for their clean-up efforts.

## 15 Fisher Street:
