The Town of Ashland has created an article for head injuries and concussions in youth activities played on town owned fields.

The intent of this came from the Wellness Committee. There has been an increase in head trauma over the last several years. The Health Agent did take the online training and is certified to do the group trainings. There would be no cost to coaches who attend training.

**Well Application:**

The board is in receipt of a well application for Charles River Village. This is an irrigation well plan for the definitive OSRD Development. The setback requirements have been met. The plan book is 624 page 5. There are no restrictions on irrigation wells. There will be no sewer.

**On a motion made by Jack Mill, and seconded by Jordan Warnick, the Board of Health voted unanimously to sign the well application for Charles River Village for an irrigation well.**

The Board of Health was made aware that the town has hired an educator/coordinator. It was suggested that this person review our regulations and provide comments.

The town was recently awarded a grant in the amount of \$110,000 which will be shared among nine towns with the intent of being self-sufficient after three years. The Health agent did speak with the Town Administrator/Accountant and the

request to set up a revolving account was denied. This will need to be researched further.
