**Meeting Minutes Acceptance for July 14<sup>th</sup> meeting tabled until next meeting.**

**Discussion of Revisions to Restricting the Sale of Tobacco and Nicotine Delivery Products Regulation.**

- To change the definition of Minor to Minimum Legal Sales Age (MLSA): The age an individual must be before that individual can be sold a tobacco product or nicotine delivery product in the municipality.
- To change some wording to section F regarding cigars to read the following:
  1. No person shall sell or distribute or cause to be sold or distributed a single cigar.
  2. No person shall sell or distribute or cause to be sold or distributed any original package of two or more cigars, unless such package is priced for retail sale at five dollars (\$5.00) or more.
  3. This Section shall not apply to:  
The sale or distribution of any single cigar having a retail price of two dollars and fifty cents (\$2.50) or more.

**Changes voted approved by a motion made by Michael Heavy, and seconded by Jordan Warnick. All in favor.**

**Discussion of Revisions to Head Trauma Regulations**

Mark Diebus, Matthew Applebaum, and Rick Laidlaw came to represent the athletic sports team as coaches. They suggested the following changes to the regulations:

- Under Section V. Education for coaches: put primary emphasis on coaches and/or regularly serving coaches to take certification. The sometimes do not have assistant coaches. Also change 21 day pre- season certification submittal to five days.
- Under Section VII. Return to Play/Exclusion to Play Paragraph B: omit “or is suspected to have suffered a concussion (i.e. exhibits symptoms)”
- Under Section VII. Return to Play/Exclusion to Play Paragraph E: omit “shall be subject to penalties as listed within this regulation by the Department” and add “may be subject to town field/facility use restrictions”.
- Omit Sections G and VIII

Health Agent will update requested changes to draft and send them to coaches prior to our next meeting 8-11-14.

The Board approved a septic design plan designed by Norfolk Engineering dated 7-21-14. This is a septic repair for a 4 bedroom house with all new septic components.

**2 Old Summer Street**

The Board approved a septic design plan designed by Land Planning, Inc. dated 7-8-14. This is a repair for a 4 bedroom house with all new septic components.
