#### **Synthetic Turf Field Precautions:**

The Board of Health is in receipt of a letter dated December 14, 2015. This letter is in regards to the community requests during the discussion in regards to the safety of the crumb rubber infill in several of the town's athletic fields. This letter will be provided to Board of Selectmen, Department of Public Services, Medway Schools and School Committee.

The Health Agent indicated that the language for procedures for coaches has been revised. The coaches will be required to do online training.

On a motion made by Jack Mill, and seconded by Mike Heavey, the Board of Health approved and signed the Fact Sheet on Synthetic Turf, and the letter on Synthetic Turf Fields dated December 14, 2015.
