The applicant went to the Conservation Commission and received a Notice of Intent to do the work. The DEP file number is 216-0844. The applicant is not seeking any variances. The perc tests were completed. The Engineer is Faist Engineering prepared for Kafai Management Inc. The testing was witnessed by Mike Catalano. This for a proposed four bedroom. The septic tank will be 1,500 gallon.

The Board of Health signed the plan.

Complaint:

The Health Agent received a complaint that there is smoking at Choate Park. The Health Agent will check with the Medway police department to see if there are regulations and enforcement options. The members indicated that the most recently accepted regulations included public places such as parks. There may need to be signage posted. These signs would need to be made through Parks and Recreation.

The public hearing was opened at 7:05 and no members from the public were present. The Chairman read the public hearing notice.

U.S. Product Safety Commission of Crumb Rubber Infill:

The Board of Health has not received a response back yet from Senator Warren requesting her assistance is releasing the U.S. Product Safety Commission review on crumb rubber infill.

2016 Budget:

The Health Agent informed the members that the Board of Health will be receiving some administrative support. There will also be a restructuring of the office areas. The logistics of this still need to be worked out.

Revising Board of Health Fees:

The Chairman opened the public hearing for the revising of the Board of Health Fees. The newspaper article with the posting was provided.

There were no residents present for the hearing.

The members were in receipt of a document which included the surrounding towns of Bellingham, Ashland, Millis and Holliston.

Member Mill recommended that the food establishment permits relating to Restaurants 0-50 seats will be increased from \$100 to \$250.00; Restaurants 50 plus seats \$200.00 to \$300.00; Frozen Dessert Permit from \$75.00 to \$100.00
