Septic System Repair:

Well Pump Application:

The Board of Health is in receipt of a well application for Steve Venincasa dated July 29, 2014 for 17 Millstone Drive. The Board of Health signed off on the application.

Other Business:**Email Tracy Stewart:**

The Board is in receipt of an email from resident Tracy Stewart regarding crumb rubber. The attachments did not open. The Board of Health wants an email to be sent to resident Stewart informing her that any information sent to the Board of Health needs to be sent as a pdf and have relevance to the crumb rubber infill topic. The document she sent was not able to be opened.

Letter to Senator Warren:

The Board of Health has not received any response from Senator Warren's office regarding the releasing of studies relating to the crumb rubber infill. The Health Agent has sent three inquiries regarding a response.

Summary of Suspected Overdose Deaths – June 9, 2015:

The Board of Health is in receipt of a document entitled "Summary of Suspected Overdose Death – June 9, 2015". This is from the Norfolk County Prescription Drug Taskforce. This includes information regarding the deaths occurring in Norfolk between 2/14/15 and 5/20/15. Out of the 27 communities, 17 has one or more overdose deaths. There were 43 noted deaths.

Fairfax County Information:

Member Warnick provided the members with information on synthetic turf fields from Fairfax County Virginia. The information in the fact sheet was prepared in consultation with Fairfax County Health Department along with other entities. This document contains a question and answer format relating to questions about synthetic turf fields. It also provided links which provide additional information and details on health assessment of synthetic turf fields.
