Kevin Perry, owner of 104 McCracken Road, was present. Mr. Perry came before the commission regarding concerns Anthony Cameron became aware of in December. Mr. Perry informed the members that after being contacted by the commission he hired EcoTec Environmental Consulting regarding getting his property re-flagged. Anthony Cameron asked what Mr. Perry's intentions are. Mr. Perry said he and his wife are building their future home. Mat Ashmankas asked if there is going to be only one house. Mr. Perry said yes. Anthony Cameron said he would like to see Mr. Perry come back with a final plan and erosion controls put in place. Mat Ashmankas suggested Mr. Perry notify Auburn conservation also because some of the property is in Auburn. The commission told Mr. Perry to come back to file a determination of applicability when he plans to build the new house.

The members signed an Extension Permit for Orders of Conditions for McGrath Road DEP file #224-569.

The clerk informed the members of a phone call that was received to from DEP regarding 36 Singletary Road. A concerned citizen sent DEP a video of silt filled water running into Singletary Lake. Vice Chairman Stead and Paul DiCicco informed the members of what precautions the land owner had tried to do. The members said the clerk will contact the homeowner again to come to the next meeting.

Roxanna Herzog of 23 Bayberry Lane was present. Ms. Herzog was wondering if sand is allowed to be put in the water of Ramshorn Pond in front of her house. Ms. Herzog said with the water down for the dam project weeds have grown and would like to place sand over them. Vice Chairman Stead and Anthony Cameron said that they believed that it is not allowed. Vice Chairman Stead said the clerk will check the regulations on doing so.

Due to a typing error Mat Ashmankas retracted his motion from November 16, 2016 to name three streams in town. Mat Ashmankas then made a motion for the commission to name stream 1 (Joseph) Waskiewicz Brook, stream 2 (Richard) Dwinell Brook, and stream 3 McCracken Brook. Anthony Cameron seconded; voted unanimously.




