JONES Request for a Determination of Applicability

PUBLIC MEETING 18 Shore Terrace

Chairman Donald Flynn read legal ad.

Dan Jones was present to explain proposal to construct an addition to existing house in the buffer zone (BZ) to Dorothy Pond. He explained he's proposing to add a second floor onto existing house, so he will not be changing the footprint, but is proposing an overhang over an existing deck which will require sonatube supports. Digging, 44' from the pond, proposed for one new support – 2 ft. diameter, 48" below grade and one existing support will be enlarged. Row of hay bales proposed as mitigation. Excavated material will be taken off site or used in front of house.

Board discussed proposal. Members voiced concern regarding roof runoff due to additional 160 sq. ft. of impervious surface being proposed, suggesting roof drains. Proponent said he would have down spouts at each end of roof. The board concurred that an entire row of hay bales is not necessary and said proponent can simply hay bale around sonatube excavations during the duration of work.

The board discussed and agreed a filing of a Notice of Intent (NOI) is not required. A Negative Determination will be issued.
