Call to order at 7:20pm.

- * Approving November meeting minutes was tabled until next month.
- * As of Dec. 4, 63 tags for the dog park have been sold.
- * Construction will not be ready for the winter.
- * Motion made to reimburse William \$171.84 for expenses related to the sign installation. Kuzmanovski made motion, Chambers seconded, all in favor.
- * The brick order has arrived and the bricks are currently in the garage. The furniture order has arrived as well. The sign has been installed. The installation of the bulletin board has not yet happened.
- * LEI is behind schedule due to the mud. LEI has not said that they cannot finish until the spring but that is anticipated. We will need to sign a contract extension, probably until April 30th.
- * Not all fence posts are in yet. They can't install the rest of them until the grading has been completed.
- * Discussion about whether or not to do a new brick order. Minimum is 100 bricks to get free shipping. We could start with pre-ordering now and have a August 15th deadline for the next order. Kuzmanovski will put this on the website. We could also do engraved paw-shaped stones. Connors will obtain prices and Kuzmanovski will do a flyer for the paws as well as a flyer for the next round of regular bricks. Pricing margin for paws was discussed. One possibility was suggested to do a 100% markup but limit it at \$80. We will think on this and discuss at the next meeting.
- * Friends Group update: They will need several people to help out with spreading mulch in the spring. There has been no change in income since the last meeting. Several state filings will need to be filed soon which have fees associated with them. The group's money is dwindling.
- * Connors reported that there is approximately \$500 in the town account so we will need to focus on raising money through the Friend's Group.

* Poker Tournament update: We should do it late February or the first weekend in March. We need to book a date soon because the VFW is already booking into February.

* Just Paint fundraiser: Chambers will look into booking one for late January.

* Uno's fundraiser: Discussion was had on whether or not to plan one but nothing was decided.

* Delaporta is expecting to donate \$400 from her real estate business based on business she obtained as a referral from the dog park and an additional \$200 may be in the works as well.

* Kuzmanovski will look into the possibility of having her friend do a Pampered Chef fundraiser for us.

* We need a photo of Harris-Keddy and her dog for the website.

* Motion to discuss made by Kuzmanovski, seconded by Chambers, all voted in favor. Adjourned at 8:17pm.
