Meeting called to order at 7:00p.m.

Motioned by Gauthier, seconded by Girard to accept the minutes of March 30, 2009 as written. Unanimous.

Motioned by Gauthier, seconded by Kupcinskas to accept the minutes of April 6, 2009 as written. Unanimous.

Michael O'Connor: I spoke to the Tom Fox and he is available to come in to meet with us on Monday, April 27, 2009. We will be discussing the Warrant and the FY2010 Budget. Based on the meeting between the School Committee and the Board of Selectmen, Bob has come back with only two changes in his budget. The School Committee had some changes in their budget to reflect the 60% number. They almost went on to other business before voting on the budget split last night.

Bob Spain: I have also increased the local receipts by \$32,000.

BUDGET RECOMMENDATIONS

Finance Director

The local receipts have been adjusted by \$32,000 to lower the amount that the School had to reduce their budget by.

Donald Gauthier: Where is this money coming from?

Bob Spain: This would be from the increase in fees.

Michael O'Connor: It would also be money that would have been in the FY2011 Free Cash.

Michael O'Connor: The Planning Board has some problems with a few of the articles that they will be discussing at Town Meeting. We will leave our recommendations as they are. They may get up on Articles 35, 36, and 37 and indefinitely postpone them. This depends on what information they receive between now and the Town Meeting. I will put the budget article in the proper form and get the Warrant ready, so that you can go over them before I send them out to print. They need to go to print on April 15. I also revised the Finance Committee letter to the residents that appears in the front of our Finance Committee Recommendations booklet. The letter contains the correct split between the Town and the School.

Donald Gauthier: If the State cuts more revenue, are you prepared to do cuts? Bob Spain: Not yet. I have an idea on what I will have to do, but I cannot discuss that at this time. The House Budget will be coming out next week. I am not confident that it will stay the same.
