# FINANCE COMMITTEE Minutes

Date: June 9, 2009 Time: 7:00pm.

# Meeting called to order at 7:00p.m.

### Tom Fox, Town Moderator, was in at 7:00p.m.

Motioned by Gauthier, seconded by Kupcinskas to open the Public Hearing. Unanimous.

Michael O'Connor: The warrant has five articles. I have just been informed that one of the articles may not be a legal article.

Brian Turbitt: You can pass that article. It is for FY2010.

Michael O'Connor: The first article is to redo Article 4 of the Annual Town Meeting. Article 3 is for a prior year unpaid bill.

Tom Fox: this would need a 90% vote at the Special Town Meeting.

Michael O'Connor: Article 4 is on there because the Town Manager did not have a figure for the Annual Town Meeting.

Tom Fox: Is this a confirmed number?

Michael O'Connor: that is the figure that he gave to me. Article 5 is for work to be done on the Aerial Scope. The truck is going out next week, but will not be billed prior to June 30<sup>th</sup>. This would authorize the expenditure beyond the June 30<sup>th</sup> date. The amount approved by the Fiscal 2009 Annual Town Meeting was for \$31,408. Bob explained that this would authorize spending beyond June 30.

Tom Fox: The wording is very vague. It doesn't explain where the transfers are going. Michael O'Connor: It explains what it is paying for. It just doesn't state a specific account.

Tom Fox: I hope that Town Counsel looked at these before the warrant was posted. I would like to make sure that Town Counsel has reviewed all of these articles. I want to make sure that what we bring to Town Meeting is already reviewed.

#### Bob Spain, Town Manager, was in at 7:20p.m.

Michael O'Connor: Articles 4 and 5 are written in a way that we haven't seen before. Bob Spain: They are being transferred to the article so that the bills can be paid after June 30. The Finance Director will set up a special account for these articles so that they can be accessed when payment is needed.

Tom Fox: The town meeting should know where the money is going.

Michael O'Connor: The Town Manager and the School Superintendent gave us their changes. The Town Manager kept the State Aid as it was on May 5. The total changes come to about \$230,000, which is less than 1% of the total budget. The School Department savings from insurance is \$174,511, which will be included in their budget under instruction. We need to vote on these numbers at the Special Town Meeting. There was a control system that was needed for the Gasoline/Diesel account. That was fixed in this fiscal year, which saved the Town \$19,400. The Fire Hydrant Expenses came in \$5,000 over what was voted on at Town Meeting. We will need to rescind the votes and re-vote the new numbers.

Daniel Girard: Do we need to break all of this out?

Michael O'Connor: We just need to explain that no management positions have had any salary changes. We will be rescinding what was voted on and re-voting the dollar amount. Is this similar to what would be done at Town Meeting?

Tom Fox: I have never done this before. You don't need to rescind the votes since it was voted on at town Meeting. You just have to vote the new numbers.

Michael O'Connor: If we get State numbers before the 23<sup>rd</sup>, then there will be more adjustments made.

Tom Fox: I don't feel comfortable with the State figures that we have.

Michael O'Connor: I will make sure that our cover letter states that the State numbers have not changed since the May 5 Annual Town Meeting.

Motioned by Kupcinskas, seconded by Girard to close the public hearing at 7:50p.m. Unanimous.
