**REVIEW OF A.L.I.C.E. DRILL**

Chief Hamilton said the A.L.I.C.E. drill went well and the Fire Department did a good job. It took the students 14-minutes to get from the school to the church once the activation sounded.

**NEW PATCH DESIGN**

Chief Hamilton has been working on a new patch for the fire department. Deputy Chief Rudge suggested including the date the fire department was established - "March 5, 1833". Several designs were reviewed. This will be discussed again.

The map of CareOne needs to be updated before the PIP can be approved.

**OLD & NEW BUSINESS**

- Chief Hamilton told the Board that recruit Donald Wysote passed the FF1 practical. Asst. Chief Gasco made a motion to appoint Donald Wysote as a regular pending completion of driver training and pump training. Once completed, recruit Wysote's appointment as a regular will be retroactive to May 1, 2017. This was seconded by Deputy Chief Rudge and carried on a 4-0 vote.
- The Tri-State Meet in Webster will be held on May 21, 2017. Hose 1 will attend.
- The Millbury Redevelopment Authority will hold a Food Truck Festival on May 21, 2017 at Windle Field. Rescue 1 and the Explorers will attend.
- Auburn is holding a Firefighter Sunday on June 18, 2017. A ceremony will be held at Fire HQ along with a short parade. Engine 2 will be asked to attend.

- Deputy Chief Rudge said the fire department should support the school department at tomorrow night's Town Meeting. Board members agreed.
- Deputy Chief Rudge said he spoke with Capt. King about not wearing gear at the recent incident on Harris Avenue.
- Deputy Chief Rudge asked if the barriers at Westview Avenue will be removed. Chief Hamilton will check with the Town Planner.
- Deputy Chief Rudge asked for an update on the ID badges. Asst. Chief Gasco will contact Edd Cote to get the remaining pictures done on 5/8/17.
- Asst. Chief Gasco said he is contacting the few guys who missed the "sizing" for leather boots.
- Asst. Chief Silver told the Board he has Recruit Paszkowski's training pack, bottle, and mask.
- Asst. Chief Silver told the Board the foam system on Engine 3 needs to be cleaned out.

Asst. Chief Silver made a motion to adjourn at 19:35.
