The meeting was called to order by Chairman Marlborough.

The Field Assignment forms will be sent out to the people who used the fields last year. Kristin Wall from the school contacted Mr. Marlborough stating that she was behind and would not be scheduling a field assignment day at Shaw School this year. The Commissioners decided to mail them out and place an ad stating that the forms are available in the Town Manager's office.

The tour of the fields has been set up for April 6, 2013 at 1:00 pm.

Old Business

Mr. Willette is happy to have the Easter Bunny on the Common this year. It will be held on March 30th from 12:00 pm to 4:00 pm.

Motion to approve the Easter Bunny use of Common on March 30th made by Mr. Hayes, seconded by Mr. Marlborough.
