Motion made by Mr. Dufresne to have Peewee Sports Academy July 23 – 27, 2012 9am-12pm, pending approval from the Board of Health, seconded by Mr. Hayes.


Motion made by Mr. Hayes, seconded by Mr. Dufresne to adjourn the meeting at 7:20 p.m.


