New Business

Trent Wilhite wanted to use Washington Street Park or any park for a soccer camp. He is looking to start a program in town and looking for 1 ½ hr. sessions Tues & Thurs. The Commission advised Mr. Wilhite that Shaw School would be a better alternative for him as all the parks in town are reserved by leagues until July 31st and he would need to speak to the school for that use.

Laurie Connors, Town Planner, spoke regarding the playground reps. and they are looking for what we want to spend and what equipment we need. The DPW Director agreed to paint the existing structure and clean it. He suggests rubber mulch as it is cheap, lasts long and is ADA assessable. They are looking at adding new components to existing structure. She met with the O'Brien rep today. For \$46,000 we can do approximately nine ADA panels, the swings and a stand-alone structure. The swings can be put near the parking lot so we do not have to put a huge path to it. The DPW director will put up the actual swing set and we will buy the ADA swing. Laurie has gotten an ADA picnic table from the VFW as they are tearing down the pavilion and they will put it at Washington St Park. She will be meeting with the Playpro rep. on Thursday and get their pricing as well. She can get added points for the grant application if they add trees to the park. She can talk to the tree warden to see if there are any funds available. She will update the Commission at the next meeting.

Motion to move the June 19th meeting to June 26th made by Mr. Dufresne, seconded by Mr. Ayotte.
Motion carried unanimously.

Old Business






