Ms. Brady-Pojani opened the public hearing at 5:50 pm.

FY 2011 Budget Vote

Ms. Brady-Pojani asked for a motion to approve the FY2011 Budget for 17,265,902 (\$17,389,366 with Windle Field, School Committee Salaries and Athletic Budget). This number is with the Medicaid amount of \$96,578 taken out of the budget. Mr. Borowski made a motion to approve the FY2011 budget and Mr. Corey seconded the motion. All approved (5-0). Ms. Brady-Pojani closed the public hearing.

MHS Drainage Project

A discussion took place regarding the approval to complete High School Drainage Project. Mr. Bedard stated that he looked at the utility and grounds supply accounts and there would be enough extra money to pay for the completion of the High School Drainage Project. Mr. Clawson asked if any money to be taken from the prepay Special Education budget. Mrs. Hitchcock stated that if need be they could use some of that account. Mr. Corey asked if there was enough money in the Grounds Supply account to finish the school year. Mr. Bedard stated that it would be tight but there will be enough money in the account (\$4,000 remaining) until the July 1st new budget. Mrs. Hitchcock stated that they are looking for a vote to give the School Department the authority to use the funds from these accounts as long as the money is available to pay for the completion of the High School Drainage Project. Mr. Borowski made a motion to grant authority to the School Department to fund the Drainage Project from these accounts with some flexibility if necessary. Mr. Clawson seconded the motion. All approved (5-0). Ms. Brady-Pojani asked that a letter be sent to the abutters to let them know that the project will be completed.

Medicaid Warrant Article

A discussion took place regarding the Medicaid Warrant Article. Mr. Borowski made a motion to approve the Warrant Article for \$96,578 in Medicaid reimbursement and Mr. Corey seconded the motion. All approved (5-0

Mrs. Hitchcock stated that the student parking fees Warrant Article had been approved at the last meeting.

Mrs. Hitchcock stated that the soil testing at Windle Field will be done on Friday, March 5th.

Future Meetings will be March 10th, March 17th, and March 24th.

Ms. Brady-Pojani asked for a vote to go into Executive Session for contract negotiations. Mr. Corey - yes, Mr. Borowski - Yes, Mr. Clawson - yes, Mrs. Vigneau - yes, and Ms. Brady-Pojani - yes.
