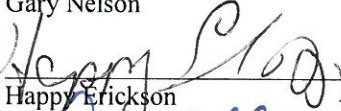
ITEM TEN – ADJOURNMENT

At 5:40 p.m. Happy Erickson motioned to adjourn the meeting, seconded by Lisa Allain.

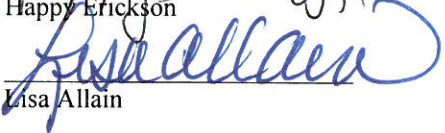
