
ITEM TEN – ADDITIONAL TOPICS

The Board took into consideration on what Mr. Lavine was saying and asked the secretary to look into seeing how other town go about the sewer betterment process.


ITEM ELEVEN – ADJOURNMENT

At 6:00 p.m. Happy Erickson made the motion to adjourn the meeting and Lisa Allain seconded all in favor.


