Chairman Nelson spoke about the Elm Court pump station being pushed out until possibly next fiscal year because National Grid is holding up the project.



Chairman Nelson also discussed the Sewer rates going up and he would like to raise the Betterment Fees and Connection Fees.


ITEM ELEVEN – ADJOURNMENT

At 6:20 p.m. Lisa Allain made the motion to adjourn the meeting and Happy Erickson seconded all in favor.


