- Elm Ct. holding off on design, waiting for NGrid meeting regarding easement.
- Elmwood St. will be relocating the station location.
- Rayburn configuring with the original wet well which will be less expensive than blasting for a new wet well.
- Warren St. wet well same location.
- Wheelock Ave. is a challenge from physical aspects will need construction easement.
